 - If the town has maintained this roadway for over the 4 year Florida Statue stipulation, the road can be paved where the maintenance has been. The funds would have to come from the General Fund budget. (FY 2012/13 Road Construction budget is \$17800.00)
 - Property owners can deed property to the town for a public ROW and once the road is in the ownership of the town we can apply for CDBG funding for paving
 - Mr. and Mrs. Smith can alone deed property to the town for a public ROW and once the road is in the ownership of the town we can apply for CDBG funding for paving
