## **OLD BUSINESS**:

- Four (4) bids were obtained for crack repair, sealing and inspection of storm drains, located at in front of 133 Creekgate Ct and at the corner of Crestgate/Tangelgate, for community roads. A motion was made by Skip Leinster, seconded by Barbara Price, to accept bid and contract the Brenaman Co to do work. Motion carried.

- Association Insurance renewal with Erie, November.
- Capital Reserve deposits are posting correctly after re-sale.
- CAI Membership: Barb shared more information and explained about benefit to managers and company to EAM, will inquire about costs.

# **NEW BUSINESS**:

- 2019 Budget approved, there will be no increase in assessments this year.
- CD Renewal: Pam rolled over three (3) CDs that matured.
  - 1) August 2, 2018 \$5817.29 from Members 1st FCU, to Members 1st FCU for 29 months at 2.50%. Maturity date: 12/31/2020.
  - 2) August 20, 2018 \$6124.76 from Members 1st FCU to Citadel Bank for 30 months at 2.75%. Maturity date: 02/20/2021.
  - 3) October 2, 2018 \$5256.49 from Fulton Bank to Citadel Bank for 20 months at 2.55%. Maturity date: 6/02/2020.

 Coupon books for assessments for 2019 assessments will arrive to Homeowners, approximately second week of December.

Leaf cleanup will not be performed under current contract with landscaping contractor,

Full Effect.

Homeowners to receive notice from Board of Directors and EAM. The Executive Board of Directors decided unanimously to not include any leaf removal for these reasons:

(1) Many properties in Crossgates Manor HOA do not have leaves.

(2) Many properties in Crossgates Manor have leaves from the <u>common</u> (Crossgates "Master" Homeowners Association.).

(3) Leaf removal would add a substantial raise in Assessments to all Homeowners.
