Organization Requirements for Application

The Board meets on the third Tuesday of each month to review requests and determine whether or not to grant funding to those individuals, families, and 501(c)3 nonprofit organizations that qualify and have submitted the required, **fully completed** application. **Any applications that are not complete may not be considered by the Board and can be declined without further review.** The application deadline is the 5th of the month to be reviewed at that month's meeting. First time applications take precedence. You may forward the application by one of three methods listed below:
