- Show closes/Removal of Art - Saturday, October 12 between 3:00-6:00 pm\*\*

**ELIGIBILITY:**

- This is a judged show and is open to all members and non-members of Wayne Arts
- Works that have previously been exhibited at Wayne Arts are not eligible.
- All work must be original by the artist.

**DESCRIPTION:** "This exhibit broadly explores the themes of Earth, Wind and Fire. From ancient methods to new technology, whether subject matter or artistic process let your imagination run free and show us your version of the elements, what they can do or that represents the properties of earth, wind and/or fire. "

**ENTRY FEES:**

- The fee is \$20 for members / \$35 for non-members for up to three pieces (Includes Free one year membership).
- Credit cards, cash or checks payable to Wayne Arts are accepted.
- *All fees are non-refundable.*

**PRESENTATION SPECIFICATIONS:** All work must be delivered to the gallery "Installation Ready"

2-D Art (Paintings, Drawings, Prints, Photographs, etc):

- All 2-D Art must be "installation ready" *wired for hanging so the wire does not show when hung.*
- Works on canvas must be neatly wrapped with staple free edges.
- Framed works larger than 18 x 24" must be framed using plexiglass/acrylic, not regular glass, due to weight.
- Frames and any mats used need to be clean and in good repair.
- Works must not exceed 72 United Inches *including framing* (1 length + 1 width, example 16 x 20" piece is 36 UI).

3-D Art (Sculptures, Ceramics, etc):

- Art work should not exceed 40 pounds in weight unless approved by the Show Chair. Pedestals may be available for use depending on size of sculpture. Check with Wayne Arts before entering.

*\*Wayne Arts reserves the right to reject any art that does not meet Presentation Specifications.*

**COMMISSION:** A commission of 25% will be charged for the sale of work. Works not for sale must be marked NFS on the entry form. Monies will be paid to the artist at the end of the show. All sales are handled through Wayne Arts Gift Shop. Wayne Arts will assume responsibility for paying the sales tax.

- *All work including work sold during the show must remain in the gallery until the end of the show.*

**AWARDS:** This is a judged show. Cash prizes will be awarded. Only one award may be given to an individual. Award recipients will be notified by the Show Chair. Award winners must be present or represented at the opening.

*\*The decision of the juror is final.*

**LIABILITY:**

While all reasonable care will be taken in handling work WCCA Does not carry insurance for submitted works and will not assume responsibility for any damage to the artwork during delivery, installation, exhibit and de-installation including, but not limited to normal wear and tear, such as minor nicks to frames or scratches to Plexiglas. It is suggested that an artist wanting more protection insure his or her own art (some homeowner's policies may include protection and should be checked).

**USE OF IMAGES:**

All entrants agree that any work they submit to the Wayne Arts' "Anything Goes" Show may be photographed and used for marketing and promotional purposes directly related to the Show. This use may include publication in any Wayne Arts' publications, printed materials, advertisements, or electronic media, including but not limited to the Wayne Arts' website, newsletter, and Facebook page. *Any image used by the Wayne Arts shall carry a credit line of the artist. Copyright and all other rights remain that of the artist.*
