At which meeting certain proceedings were had, among which were the following:

Commissioner Spokane presented a certain ordinance, and moved its adoption, and thereupon Commissioner O. E. Poyth seconded said motion to adopt said ordinance, and said motion being then and there put to a vote of the "Ayes" and "Nays", and the roll being called, said ordinance was unanimously adopted by the vote of all of the Commissioners present, each of said Commissioners voting "Aye", and there being no votes "Nay", which ordinance is in the words and figures following, to-wit:

ORDINANCE NO. 585 . 583

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF BONDS OF THE CITY OF GARNETT, ANDERSON COUNTY, STATE OF KANSAS, FOR THE PURPOSE OF EXTENDING THE WATER-WORKS OF SAID CITY TO THE AMOUNT OF EIGHT THOUSAND DOLLARS, AUTHORIZED AT A SPECIAL ELECTION DULY CALLED AND HELD IN SAID CITY.

WHEREAS, at a special election duly called and held in the City of Garnett, Anderson County, Kansas, in all respects in accordance with the statutes of the State of Kansas in relation thereto, and which election was held on the 14th day of October, A.D. 1913, at which more than a majority of the qualified electors, voting at said special election,



voted in favor of the proposition to authorize the Board of Commissioners of said City of Garnett, to issue the bonds of said City to the amount of Eight Thousand Dollars (\$8,000), for the purpose of providing funds to extend and improve the waterworks of said city;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF GARNETT, KANSAS:

SECTION 1. That the negotiable coupon bonds of the City of Garnett, Kansas, to the aggregate amount of Eight Thousand Dollars (\$8,000) be and the same are hereby authorized and ordered to be issued for the purpose of providing funds to extend the waterworks of the City of Garnett, Kansas. Said bonds shall bear date of November 1, A. D. 1913; shall be eight (8) in number, numbered from one to eight (1-8) inclusive; of the denomination of One Thousand Dollars (\$1,000) each; shall be due and payable absolutely twenty (20) years from the date thereof, said bonds shall bear interest at the rate of five per centum (5%) per annum, payable semi-annually on the first day of May and of November, in each year, which interest payments shall be evidenced by and payable upon the presentation and surrender of proper coupons attached to each bond, and both principal and interest shall be payable at the office of the State Treasurer of the State of Kansas.

SECTION 2. That said bonds and coupons shall be substantially in the following forms, to-wit:

KNOW ALL MEN BY THESE PRESENTS, That the CITY OF GARNETT, in the County of ANDERSON, State of KANSAS, acknowledges itself to owe and for value received hereby promises to pay bearer, the sum of ONE THOUSAND DOLLARS, lawful money of the United States of America, on November 1, 1933, together with the interest on said sum from the date hereof until paid, at the rate of five per centum (5%) per annum, payable semi-annually on the first day of May and of November, in each year, upon presentation and surrender of the interest coupons hereto attached, as the installments thereof severally become due; both principal and interest payable in lawful money of the United States of America, at the Fiscal Agency of the State of Kansas, at the office of the State Treasurer, in the City of Topeka, Kansas. And for the prompt



payment of the principal and interest of this bond as the installments thereof severally become due, the full faith, credit and resources of said city are hereby irrevocably pledged.

THIS BOND is one of a series of bonds issued by the said city for the purpose of providing funds for the extension and construction to the present waterworks system, and are authorized by more than a majority of the qualified electors of the said city voting at an election duly called and held therein, and in all respects in full compliance with the requirements of law including the provisions of an Act of the Legislature of the State of Kansas entitled: "AN ACT authorizing certain cities to issue bonds for natural gas, water, light, and heating purposes," approved March 4, 1905, and all Acts of the Legislature amendatory thereof and supplemental thereto, and the provisions of Chapters 75 and 123 of the Laws of 1913, and pursuant to the provisions of an ordinance duly passed by the Board of Commissioners of the said city. And it is hereby certified and recited that all acts, conditions and things required by the laws of the State of Kansas to be done precedent to and in the issuance of this bond have been properly done, happened and been performed in regular and due form and time as required by law, and that the total indebtedness of said city of Garnett, including this bond does not exceed any constitutional or statutory limitation.

SECTION 4. That after said bonds shall be so executed and registered, they shall be delivered to the purchaser thereof, upon payment of the purchase price, and all proceeds derived from such sale shall be placed in a special fund to be used solely for the purpose of ~~for~~ the purpose for which said bonds recite they are being issued.

SECTION 5. That the Mayor and Board of Commissioners of said City of Garnett, shall annually for each of the years 1913 to 1932, both inclusive, levy on all of the taxable property, real, personal or mixed, within the corporate limits of said city, such taxes in addition to all other taxes, as shall be sufficient to raise the amount required to meet one year's interest on the bonds issued hereunder outstanding, when and as the same become due, and also the further sum of four hundred dollars (\$400) annually to liquidate the principal thereof at maturity.

SECTION 6. THAT THIS ORDINANCE shall be in full force and effect from and after the time required by law from its passage, approval and publication in the official paper of said city.
