### Immediate Need Direct Cremation Packages Range \$1295 - \$1776

If you want to arrange for a direct cremation, you can use an unfinished wood box or an alternative container. Alternative containers may be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is \$130 and is included in all packages and listed below as an Alternative Container. Should one be provided by the purchaser, the cost will be deducted from the package cost.

Package listed as "Online" is for at-need arrangements only.

#### **\*Online Fast Track Services (Absolute Best Overall Value) Freedom Direct Cremation Package:**

Online partial basic professional services, expedited services of securing a doctor signature via EDRS, notification to Social Security, transportation or receiving deceased from place of death or holding facility (35 mile radius), refrigeration care (up to 10 days), prioritized rush cremation services (cremation completed within 1-2 business days from obtaining permit) includes cremation for an individual up to 275 lbs., expedited filing of required documents for a direct cremation service, county approval fee if applicable up to \$50, expedited retrieval / receiving of death certificates from a county office in less than 10 business days, priority mailing of the death certificate order, one death certificate. TSA compliant temporary urn included.

Select one additional premium service at no additional fee.

- Post cremation conference (by dedicated appointment) for the return of the cremated remains.
- Shipping of cremated remains to the lower 48 states, option includes temporary urn
- Unattended sea scattering of the cremated remains with GPS location and certificate.

#### **Traditional In Office Direct Cremation Package (Immediate Need):**

Includes our basic professional service fee for a traditional in office conference, securing a doctor signature via EDRS, notification to Social Security, transportation or receiving deceased from place of death or holding facility (35 mile radius), refrigeration care (up to 10 days), basic cremation fee for individual up to 275 lbs., the filing of required documents for a direct cremation service, retrieval or receiving of death certificates from a county office & a post cremation conference at our office for the return of the cremated remains in a fiberboard box, by appointment. This arrangement does not include county fees, or any services not listed above. Applies to in office, faxed, mailed or emailed arrangements.

#### **Standard (\*Online Basic) Direct Cremation Package:**

Online partial basic professional services, basic securing and filing of the death certificate through EDRS, notification to Social Security, local transportation (35-mile radius), refrigeration (10 days), basic cremation process for deceased less than 275 lbs. (cremation completion estimated 10-14 days), receiving or retrieving death certificates from county office, cremation approval fee if applicable (up to \$50), one death certificate, one cremation certificate and cremated remains returned in a standard cardboard box.

\*- Online cremation packages are for immediate cremation needs only and client must complete arrangements via our website paperless forms only (faxing or mailing forms is not considered an online arrangement). CSBS does not ship death certificates with cremated remains. Standard payment of cash or certified check accepted. Credit cards processed via our alternative cremation forms for these arrangements will incur an additional convenience fee of 2.9%. Payment in full is required prior to cremation or filing of legal documents. Office hours are by appointment only, no weekends, no holidays.

Any additional service requests added to any package above will be charged by itemized fee, as indicated on our General Price List.

The Federal Trade Commission requires the disclosure of costs of each individual funeral item and service offered. You are entitled to complete information via telephone, mail or personal inquiry. Under these regulations, those who offer Direct Cremation must tell you that Florida State Law does not require embalming, or the use of a casket for direct cremations.
