## **Public Participation**

#### As Discussed:

- D.A. Michaela payments on outstanding liens for 176 Plane Bank Road, 460W and 192 Plane Bank Road, 461W.
- Liens \$1,388.17 on both properties- outstanding balances due, trailer exonerated in 2009, billing continued until 2011.

Motion made by Raymond Guzic, Jr. 2<sup>nd</sup> Rita Butterbaugh to exonerate the liens for 460W and 461W, and to exonerate from any remaining balances and to accept the two payments of \$1,388.17 for each property. Roll call, all in favor, Motion passed.

- ➤ Account # 461W exoneration amount is \$ 864.30 approximately one year and five months of invoicing from 2011.
- Account # 460W exoneration amount is \$ 137.33.

- Closing of the Debt Service Funds Account- due to bank transition the September loan payment was not paid, monthly transfers dismissed, payment is now being debited from the CMSA General fund. Minimum balances cannot be maintained without service charges from Somerset Trust.

- Grant funds have been received by Central Mainline Sewer Authority, awaiting a copy of the grant with all the conditions, may or may not require a separate grant audit.
- Concrete riser completed on Bear Rock Run- the Bear Rock Run Subdivision.
- Equivalent Dwelling Unit count for Lilly Borough Sewer Authority and the proposed letter to be sent to LBSA for the annual allocation and chapter 94 Report.
- The PA Small Water and Sewer Grant- Due December 2019 discussion on what to apply for A. Jones Street sanitary sewer extension.
  - B. Control panel upgrades at the wastewater treatment plant.
- Plant Operations and avoiding future errors and to evade future failure of vital equipment. Penalties and fines from the DEP.
- Resolution 2-2019- CMSA and LBSA request a PA Small Water and Sewer Program Grant of \$96,000.00 from the Commonwealth of PA to be used for Control systems upgrades at the CMSA wastewater treatment plant.

- Monthly DMR's
- > Sludge press- sheared off a drive coupling- parts ordered may take up to six weeks to

receive spare part. Sludge press can be used-very slowly.

- Flow meter downloaded and report attached to packets.
- > Three Re-pressure tests were completed.

New home on Bear Rock Road- new lateral drawing.

Mountain Road lateral moved to new home, existing structure will be moved or razed. New lateral tested

> Inspection completed on new line extension for the Lilly Estates Phase II.

- New local polymer supplier, approximately ½ price of the current supplier, current supplier charging CMSA \$1,593.29 new supplier approximately \$600.00 for a 55 gallon drum. Works just as well and maybe even better at removing excess water from the sludge, which will result
- Comcast \$166.00 per month vs. \$327.46 Verizon phone and internet for the CMSA wastewater plant. Agreement will need to be signed.

Motion made Raymond Guzic, Jr., 2<sup>nd</sup> Rita Butterbaugh to authorize the plant manager to change internet and phone provider to Comcast and to accept the agreement for services through Comcast pending review. Roll call, all in favor, Motion passed.

Moschgat residence on 1387 Dulancey Drive not to be razed as previous reported to CMSA, resident continues to pay the monthly sewage fee to keep her tap. Will be pressure tested at time of sewage re-connection.
