

ORDINANCE 1993-7

AN ORDINANCE AMENDING ORDINANCE 1989-4, AN ORDINANCE SETTING OUT TRAFFIC REGULATIONS AND PROVIDING PENALTIES

WHEREAS, the Cloverdale Police Chief has surveyed traffic flow within the immediate downtown area of Cloverdale, Indiana, and

WHEREAS, it has been determined that traffic flow would be expedited by the establishment of one-way alleys.

NOW, THEREFORE, BE IT ORDAINED by the Town of Board of the Town of Cloverdale that Ordinance 1989-4 be amended by adding the following to said ordinance:

B., 1.1 "One-Way" Streets and Alleys:

The following streets and alleys shall be designated as follows:

- a. The alley running between U.S. 231 and Grant Street south of Columbus Street shall be one-way west.
- b. The north/south alley between Columbus Street and Market Street just west of U.S. 231 shall be one-way south.

Paragraph B., 3. shall be amended by adding the following:

A violation of the one-way designation which has been posted at the beginning of the alley shall be punishable by a fine of \$20.00.

This Ordinance shall be in full force and effect thirty (30) days after its publication.
