The owner or person in charge of any dog or other animal shall not permit solid fecal matter of such animal to deposit on any street, alley or other public or private property, unless such matter is immediately removed therefrom by said owner or person in charge. This section shall not apply to a person who is visually or physically disabled or to horses when used as a mode of transportation.

(Code 1986, § 7-1-10)

Sec. 26-35. - Horse and carriages.

No person shall ride a horse or drive a horse-driven vehicle in any park, except on roads or designated bridle paths, except when approval of the parks committee is first obtained. It shall be unlawful for any person to ride a horse or drive a horse-drawn vehicle in a careless, negligent or reckless manner which may endanger the safety and well-being of others. Any person riding a horse or driving a horse-driven vehicle on any public property in the village shall be responsible for immediate removal of horse feces.
