Gary Silver: The county sent back the 239 reviews as a local determination. There were also a few comments from the DOT that need to be given to the applicant. Do the board members have questions, comments, or concerns?

Steven Green: My only concern is the deliveries blocking traffic on the main street. Can we have the deliveries done in the back of the building?

Gary Silver: D.O.T. recommended that all deliveries be in the rear. We can make a condition on the approval to have the deliveries come into the back.
