WHEREAS, the said ARCHITECTURAL CONTROL COMMITTEE is empowered to review and approve any and all construction plans, specifications, and related building materials, and

WHEREAS, the Plans, Specifications and related construction materials described below have been submitted to the said ARCHITECTURAL CONTROL COMMITTEE by GENERAL HOMES CORPORATION, a Texas Corporation, with a request that said Plans, Specifications and related materials be approved by the Committee, and

WHEREAS, the said ARCHITECTURAL CONTROL COMMITTEE is now composed of Kenneth F. Belanger, Nancy Dawson and Terese Buess, these members, have in accordance with Article IV, Section 2 of the Declaration of Covenants, Conditions and Restrictions, duly designated Terese Buess as the representative to act on behalf of the Committee for Barrington Place.

NOW, THEREFORE, the following matters are undertaken and approved on behalf of the Committee;

Approval is hereby given for the construction of dwellings and related improvements by GENERAL HOMES CORPORATION, a Texas Corporation, in the subdivision known as Barrington Place, Section I of said Subdivision filed of record on Volume 129, Page 20, and Barrington Place, Section II of said subdivision filed of record on Slice Numbers 592B, 593A, 593B and 594A of the Map Records of Fort Bend County, Texas, in accordance with the Plans and Specifications that have been submitted.
