AN ORDINANCE AMENDING ORDINANCE NO. 2013-11 REGULATING THE SALE OF ALCOHOLIC LIQUORS FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

Section 1:

Ordinance No. 2013-11 is amended by deleting Section 19 and inserting in its place the following new Section 19:

Section 19. Investigation; rejection or approval of application.

Upon the filing of an application for a license to the local liquor commissioner, as provide in this Ordinance, the local liquor commissioner shall investigate the applicant for a license and shall, upon such investigation, approve or reject the application and present his/her recommendation to the Board of Trustees for approval. In approving and issuing a license, the Board of Trustees may, unless prohibited by law, temporarily or permanently waive or modify the enforcement of one or more requirements of this Ordinance if, in its sole discretion, it determines the waiver or modification of the requirement(s) will best serve the interests of Village residents and will not undermine the purpose and intent of this Ordinance.

Section 2:

This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
