Mayor's Announcement

Parks & Rec Dept. Head Lawrence Hemingway introduced the eight Summer Youth Employment award winners during the farewell to Summer Youth Program. 584 youthparticiapted in youth employment programs..

While announcing that National Suicide Prevention Awareness Month will be September, Mayor Hagerty asked anyone who knew someone who died from or attempted suicide stand. He spoke kindly of need for early awareness and intervention.

City Clerk Announcements: City Clerk Reid announced his support for elected Clerk and invited public to attend the upcoming citizen engagement event -- Participatory Budgeting Aug. 22 6:30 -8:30pm* (see below). Objections to Transfer Tax referendum close Tuesday, Aug. 14th; currently have 3. (e.g., very tight time table; not in compliance with Master Plan. Also has a petition on Harley Clark (not on agenda that night).

City Engineer Lara Biggs gave project update:

- Fountain Square pipe lining expected to be completed this week. Fountain testing to be completed by Sept. Last memorial panel to be delivered by the end of this month.
- James Park north field ... grass establishment delayed by bad weather. Hope to do weed management this fall. Hope field will be in service next spring.
- Basement flooding in 300 and 400 block of Dodge and 1600 block of Kirk ... as a result
 of sewer lining work underway when a major rains storm hit. Says contractor is working
 to resolve insurance claims related to it. Says city has lined about 40 of its 160 miles of
 combined sewers. This is the first time there's been such a flooding issue. Work now is
 complete for this year.
- Sheridan Road ... Lincoln to Isabella. Work at Lincoln intersection to be completed in time for NU move in. Rest of work to continue into October. Project is on schedule.
- Robert Crown fencing to go up soon. Earth moving to start in earnest early in September. Project is on schedule

The software system will assist with the management of the Evanston Police Department through the analysis of law-enforcement related information. The License Agreement provides that years one through three will be paid through a grant from the Joyce Foundation, 321 North Clark Street, Suite 1500, Chicago, IL 60654. If the City Council decides to renew the license agreement for years four and five, the cost will be \$25,000 and \$26,000 respectively.
- **A6)** Contract with Capitol Cement Co. Inc. for 2018 Alley and Street Improvements Project Funding will be provided from the CIP Fund as follows: 2018 General Obligation Bonds in the amount of \$275,940, the Special Assessment Fund in the amount of \$213,645, and Community Development Block Grant funds in the amount of \$385,176.30 totaling \$874,761.30.

This will modify the existing agreement amount from \$984,551.69 to \$1,049,412.79 and extend the contract deadline from December 31, 2018 to September 30, 2019. Funding for this work will be through the Washington National TIF fund from liquidated damages assessed against the construction contractor for failure to complete the work within the specified time. As of August 1, 2018 a total of \$153,900.00 in liquidated damages has been assessed against the construction contractor.

- **A11)** Consulting Contract Amendment #3. Design and Construction Engineering Services on Sherman Avenue between Davis Street and Church Street to amend an existing engineering services contract for the Fountain Square Renovation Project (RFP No. 15-68) with Christopher B. Burke Engineering, Ltd (9575 W. Higgins Road, Suite 600, Rosemont, IL 60018), in the amount of \$64,861.10. This will modify the existing agreement amount from \$984,551.69 to \$1,049,412.79 and extend the contract deadline from December 31, 2018 to September 30, 2019. The actual construction (to be awarded at a future date) will be funded partially by additional savings and through the use of an additional \$100,000 in funding from the Washington National TIF fund.

A Local Agency Agreement with the IL Dept. of Transportation (IDOT) for the Howard St. Corridor Improvement Project, Phase II Engineering (construction plans). The Agreement establishes the maximum grant funding of the engineering cost, not to exceed \$462,637, and commits Evanston to fund \$137,363 of the engineering cost. Funding for this project will be from the Capital Improvement Fund, including 2018 General Obligation Bonds in the amount of \$137,363,Surface Transportation Grant (STP) funds in the amount of \$162,637, and reimbursement from the City of Chicago in the amount of \$300,000

(A16) Resolution 55-R-18. Phase II Engineering Services Agreement for the Howard Street Corridor Improvement Project A Preliminary Engineering Services Agreement for Federal Participation with the IL Dept. of Transportation and a Professional Services Agreement with Christopher B. Burke Engineering, Ltd. (9575 W. Higgins Road, Suite 600 Rosemont, IL 60018) in the amount of \$600,000. The Howard Street Project is a joint project with the City of Chicago and 50% of the funding is provided by Chicago. The City has received a federal grant of \$162,637 through the North Shore Council of Mayors and this will be reimbursed to the City of Evanston. The remaining amount of \$137,363 will be from the Capital Improvements Fund, 2018 General Obligation Bonds,

The agreement is for 39 years with two 10 year extension provisions at the discretion of Lincolnwood.

The applicant requests relief for lot size, lot width, and to add zero parking spaces where two additional parking spaces are required. The applicant has complied with all zoning requirements and meets all of the standards for a variation for this district.
- (P7) Ordinance 77-O-18 Granting Major Zoning Relief to Eliminate Parking and Add Fencing for Firehouse Grill at 750 Chicago Avenue Grants major zoning relief to eliminate one ADA parking stall (with one remaining) and install a 3' tall fence (planter box) fronting Chicago Ave., and denying major zoning relief to install an 8' tall wood fence with a 0' street side yard (Madison St.) setback, in the C1a Commercial Mixed-Use District. The applicant has complied with all zoning requirements and meets all of the standards for a variation (for parking and the 3' fence) for this district.

Amended to be limited to lot 4 and lot 54 (this is the Poplar Metra lot and the Stewart/Central lot. This Ordinance would create a special event parking pilot program that would expand the usage of the ParkEvanston mobile app to include an on-street parking zone for

Northwestern football game days, with a daily parking rate of \$40.00. Staff recommends suspension of the rules for Introduction and Action at the August 13, 2018 City Council.

<u>For Introduction and Action</u> Alderman Revelle moves to eliminate the Stewart/Central lot from the new rule as well. Approved as amended

(A19) Ordinance 94-O-18. Amending City Code Section 10-11-17. Schedule XVII "Parking Violation Penalties" to Add Schedule XVII (L) Non-Payment of Special Event Parking Fee Amending City Code Section 10-11-17, Schedule XVII "Parking Violation Penalties" to add Schedule XVII (L) Non-Payment of Special Event Parking Fee. During the special event pilot program mentioned in item A19, the penalty fee for non-payment would be \$80.00. Staff recommends suspension of the rules for Introduction and Action at the August 13, 2018 City Council.

For Introduction and Action Approved 8-0.

(A20) Ordinance <u>92-O-18</u>, <u>Amending City Code Section 10-11-7</u>, <u>Schedule VII(C)</u>, "<u>Bus Stops and Zones</u>," <u>to Add Signed Bus Stops on Dodge Avenue from Oakton Street to Main Street</u> Amended to read east side south of Keeney instead of east side north of Keeney. Approved as amended.

(P2) Tenant-Based Rental Assistance Renewal Funding

The Housing and Homelessness Commission and staff recommend approval of a funding renewal of \$300,000 in HOME funds to continue the current Tenant- Based Rental Assistance program, administered by Connections for the Homeless. The funding will provide stable housing for two years to up to ten at- risk Evanston families with children under the age of 18 in Evanston that are underemployed, and break the cycle of poverty and instability by developing the capacity to earn a living wage to support their families and afford market rate rental housing. The increase in funding from \$250,000 to \$300,000 is due to the increasing costs to rent in Evanston. Currently, the City has a total of \$474,275.33 in available uncommitted HOME funds.

Alderman Braithwaite says he's concerned about the Paden family not receiving funding. Betty Bogg of Connections says can't discuss because the Padens are threatening litigation. Says Connections is paid in arrears. Alderman Rainey moved to support the motion to fund Connections. She said Connections is the only organization capable of administering the program. She suggests that and Braithwaite meet with Connections and the Padens to try to resolve the dispute. Funding approved.

(O2) Approval of Funding for Chicago's North Shore Convention and Visitors Bureau FY 2018 Recommend approve funding for Chicago's North Shore Convention and Visitors Bureau in the amount of \$81,174.00 for a period commencing August 14, 2018 through June 30, 2019. Alderman Fleming asks how much city gets for its funding. Gina Speckman, executive director of CNSCVB, says do tracking of hotel occupancy. Says Evanston's contribution is 4 percent of the bureau's budget. Alderman Fiske says the funding is very important to the hotels in downtown Evanston. Says it's a very tough business now. Says she's convinced it is money well spent. Approved 7-1. Alderman Fleming votes no.
