The former owner of our home at 4215 Shoreline Dr. had mentioned to me that a few years ago they had discovered a 45 caliber slug in the roof of their home. I appreciate your efforts to assist us in eliminating this threat before an injury or death occurs.

I found a text message... it looks like December 8, 2017 was the day I called police when I saw hunters floating down the river and shooting in our neighborhood. The Polk County sheriff was dispatched, called me, and told me that as long as their motor wasn't on it was legal. They did not send someone out to investigate. I also know that when Brenda Lamb and Paul Hutter purchased their house, they were told by the previous owners that at one time a bullet had gotten lodged in their roof.
SELF	John and Barb Henke	671 Sunset Ave	.426 mi	September 10, 2017, John was having a conversation with a neighbor when a bullet struck approx. 20 ft. from him on the pavement at 671 Sunset. People were running out of Sunset Park screaming that bullets were ricocheting off the trees.
