OBEDIENCE AND RALLY TRANSFERS (previously known as Move-Ups): After a dog earns its title, it may be moved up to the next class in a future trial even though the closing date has passed. This transfer may be requested if, according to the owner's records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. Transfers between "A" & "B" class at the same level are allowed. The requests for a transfer must be in writing or email and presented to the Trial Secretary or Superintendent. Email transfer information is accepted any time (days/weeks) prior to 6:00 PM Friday, December 12, 2025, and in person at the show 30 minutes before the start of the trial. Transfers may be approved, provided the class and judge are available and the class has not reached its limit.

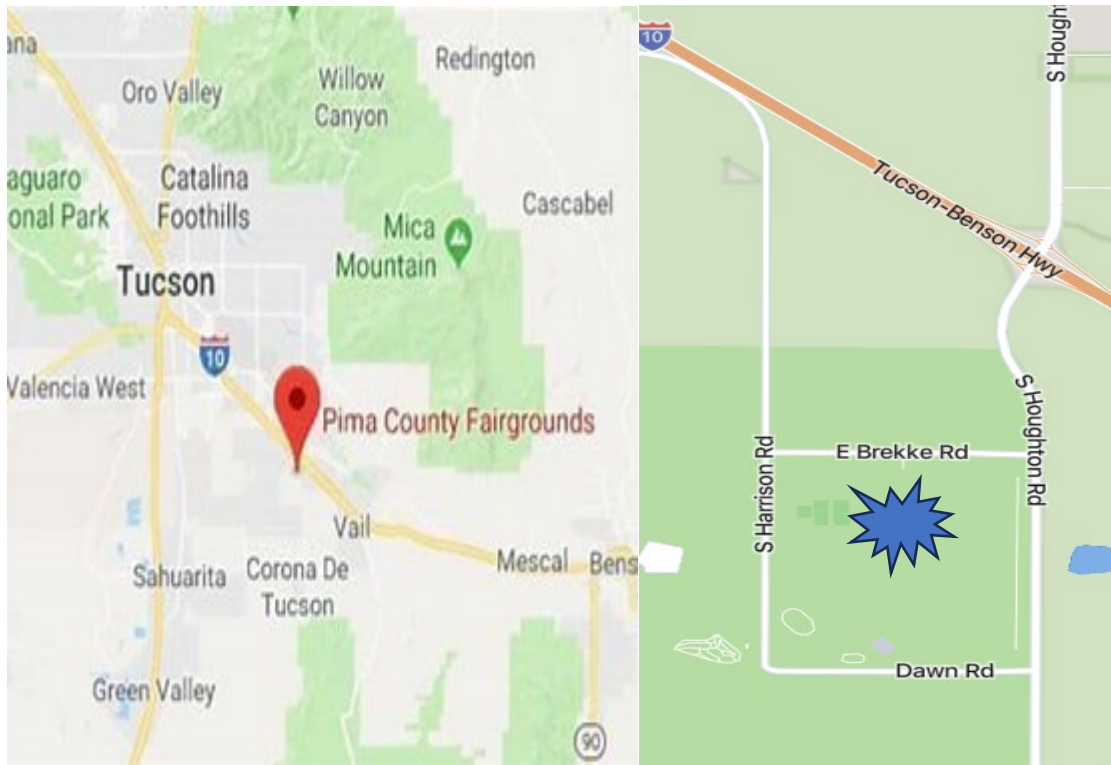

From I-10, take Houghton Road, Exit 275. Proceed south for one mile to the Pima County Fairgrounds. Turn right (west) on Brekke Road. Go a half mile to the Brekke Road entrance. Turn left and enter. Take the right fork and turn left after passing the gate. Go straight ahead to Thurber Hall (located on your left-hand side). Parking is free at the fairgrounds. The fairgrounds are located 17 miles east of downtown Tucson.

NOTICE TO EXHIBITORS - IMPORTANT TRIAL INFORMATION

- Thurber Hall will be open for set up from 1:00 PM – 6:00 PM on Thursday, Dec. 11, 2025. Exhibitors may bring in crates, chairs, and other equipment during that time and set up in designated areas. OC Match time will begin at 2:00 p.m. Any dogs not pre-entered, and wanting to compete, must submit payment prior to the start of the match at 2:00 p.m. Dogs will run in scheduled order and/or arrival order. To sign up, please complete the included Match Entry form (and mail with your lunch form if ordering lunch)
- Officers and Club Members of Old Pueblo Dog Training will be eligible to compete at these trials. Likewise, the Show Secretary, the Show Chair, and any other volunteers helping with the running and organization of these trials will be eligible to compete.
- Obedience and Rally Class Transfers will be accepted as space permits, in accordance with Chapter 1, Section 16a & b of the AKC Obedience Regulations, and Chapter 1, Section 15 & 16 of the AKC Rally Regulations. Requests for class transfers must be made in writing and presented to the Trial Secretary at least 30 minutes before the start of each day's trial. Email transfer information is accepted any time (days/weeks) prior to 6:00 PM Friday, December 12, 2025, and in person at the show 30 minutes before the start of the trial. Forms will be available at the Secretary's Table during the Trials and included with Judging Schedule. Prior to Friday, December 12, 2025 pre-trial transfer requests may be made by emailing the Trial Secretary.
- Obedience and Rally jump heights will be organized by jump height to the extent possible. Running Order in classes involving jumping exercises will be small to tall each day.
- Classes listed as "After Noon" will run in the order shown and will not start prior to 12:00 noon. All three days Graduate Novice will precede Open A & B and Graduate Open will precede Utility A & B.
- All Rally classes will have a walk-through for handlers without their dogs prior to the start of judging for that level.
- In the Novice A, Preferred Novice, and Beginner Novice Obedience classes, a walk-through prior to the start of the class will be held for handlers without their dogs. The judge will be available in the ring during this period to brief the handlers and answer any questions they might have.

- Lunches will be provided free for judges, trial stewards, show secretary, and chairpersons/ designated volunteers. In addition, water will be available for everyone as well as light morning hospitality. There are no concessions available at this trial. Show participants may order lunches using the mail-in prepayment form. Please complete the lunch form and mail with your match form to Trial Chair.
- The AKC is committed to creating a safe and respectful sport environment for all. If you need to talk to someone or need help, please call 800. 656.HOPE (National Sexual Assault Hotline) or text HOME to 741-741 for free, 24/7, confidential services from trained crisis counselors.

Dog and Crating Information

- No dogs may be left in the building overnight. Exhibitors are responsible for cleaning up after their dogs and leaving their crating areas clean.
- All dogs must always be on leash when on trial grounds except when in the designated warm up area or while competing in the ring. The entire Pima County Fairgrounds property is considered the trial grounds. For safety reasons flexi-leads may not be used in or around the building.
- CRATES & NO DOG ZONES (NDZ)! All Participants are expected to have a crate/contained place where their dog can relax. In support of the AKC rule to “exit the ring with the dog under control” there will be definite NO DOG ZONES (NDZ) at this trial. This will include checking in, arm-band pick-up, checking the rally score board, etc. We will all work together to support each and every run at our trial without adding additional “proofing” as handlers compete, enter, or exit the ring.
- Eligible unentered dogs are welcome at our trial as long as they have appropriate quiet crate behaviors. They are also welcome to participate in afternoon match time all three days at the same cost, after entered dogs. Please note, unentered dogs are NOT ELIGIBLE for use of the warm up ring before or during trial hours. Trial workers/volunteers, competitors traveling with their seniors or new show prospects – this is the show for you! Thurber Hall is a 13,000 sq ft building.
- All dogs must be on leash, or confined to a crate, when not in the ring or designated warm-up area. Crating will be in the designated crating areas.

All prizes and trophies are donated by Old Pueblo Dog Obedience Club unless sponsored. All sponsors will appear in catalog. A qualifying score is required to receive a ribbon in a regular, preferred, or optional class. High Scoring dog and High Combined ribbons and/or trophies in Obedience will come from regular classes.

In the event of a tie score, any dog not present for the runoff forfeits its rights to the ribbon and/or trophy.

SPECIAL AWARDS SATURDAY EVENT

In addition to a photo shoot set-up and a special visitor on Saturday ... there will be many awesome awards on this day. The Highest Scoring obedience dog from each group (Toy, Hound, Working, etc. and All American) will receive an award on Saturday; There will be an NQ armband Award; A Road Warrior Award; and a few other fun things to put this trial on your every year checklist (next year it will be the weekend BEFORE Orlando). Speaking of Orlando ... there will be "I was invited to Orlando, but I chose Tucson instead" small memento for anyone who was invited to Orlando.

ATTENTION EXHIBITORS

- No entry can be accepted that specifies any conditions as to its acceptance. Telegraphed, telephoned or unsigned entries cannot be accepted. Owners are responsible for errors in making out entry forms & no entry fee will be refunded in event of errors found after the closing date of entries.
- Entries not completed electronically, or not on official AKC entry forms & photocopies without Agreement & Rules on same page or reverse side are NOT ACCEPTABLE. All entry forms must show the name of the Club and the date of the show.
- Judging Programs will be emailed to the email address on the entry form. If not received by the Monday before the show, notify the Show Secretary. Please ensure that your email is legible on your entry form. Trial correspondence and confirmation will be sent via email. Please put debby@camarade.net on you approved sender list. Check Spam frequently for trial correspondence.
- Entry fees shall not be refunded in the event that a dog is absent, ill, injured, disqualified, excused by a veterinarian* or judge, or barred from competition by action of the Bench Show Committee, or because dog is ineligible to compete due to being entered incorrectly. If, because of riots, civil disturbances, or other acts beyond the control of the venue or show committee, it is impossible to open or complete the show, no refund of entry fee(s) will be made. There is no refund of entry fee for duplicate entry.
- *Refund of entry fees for bitches entered in the trial that come into season after the closing date of this show may be obtained by sending a veterinarian's certificate to the trial secretary. The certificate must be postmarked before the opening day of the show or given to the trial secretary 30 minutes before the start of the show. A \$10.00 service fee will be deducted from the refund.
- The show committee will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume liability in the event of any accident or misfortune to either dogs or exhibitors participating in the trials.
- Ribbons and/or trophies are to be picked up at the trial. None will be mailed. Any not claimed become the property of the Old Pueblo Dog Training Club, Inc.
- Hotels are considered an extension of the show site, so following the rules of the hotel with regard to pets is expected.
- This show is governed by The American Kennel Club. Exhibitors should read the AKC agreement that accompanies the entry form in this premium list.
- OLD PUEBLO DOG TRAINING CLUB may decline entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or any other cause. No one shall have any claim or recourse against the Club or any official thereof.

- RETURNED CHECKS do not constitute a valid entry fee. The Show Secretary will add a \$35.00 collection fee to the amount of each returned check.
- THE CLUB AND ITS SHOW SECRETARY will not be responsible for loss or damage to any dog or the possessions of any exhibitor, whether the result of accident or other causes. It is distinctly understood that every dog at this show is in the care, custody and control of its owner or handler during the entire time the dog is on the Show premises. The welfare of an exhibitor's child is the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control and restraint over their children at all times.
- DOGS MAY ARRIVE at any time prior to scheduled time of judging of their class. Dogs not required for further judging will be excused. Owners and handlers alone are responsible for the presence of their dogs in the judging ring. There is no rule of this Club or the AKC that requires a Judge to wait for a dog.
- RECORDING & EVENT FEES: Obedience and/or Rally entry fees include a \$3.50 AKC recording and event service fee for each recordable entry. These fees are to be collected by the Show-giving Club and paid to the American Kennel Club. (AKC Rules, Chapter 11, Section 2.)
- **IMPORTANT GROUNDS/PARKING INFORMATION:** While December can be cooler in Tucson, no dog should be left in a car without adequate ventilation (Windows down, Hatch door raised, etc.) as the sun still can heat up a vehicle even on a cooler day in the desert. ***We will take action to rescue and report any dog deemed to be in a potentially harmful situation to any Show Committee Member.***
- Entries must include the signed Agreement and Rules.
- All owners of mixed-breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked. Include only AKC titles on entries.
- Owners are responsible for errors made while filling out their entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- No refunds will be issued for overpayment of less than \$10.
- Old Pueblo Dog Training Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Exhibitors are responsible for being ready for judging when called to the ring. The judge need not wait for any dog holding up a class. Old Pueblo Dog Training Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

There will be a designated warm up area for exhibitors and their dogs during trial hours each day. Prepays will be scheduled first. Please complete the Match entry form (and mail with your lunch form if ordering lunch). Prepaid Ring times are \$5.00 for 5 minutes. Exhibitors may prepay for more than one time in any one class. If time allows, pay at show will be allowed for \$8.00 for 5 minutes, but must be paid prior to the start of the match.
