

Ordinance Number 704

An ordinance appropriating certain money's .

Be it ordained by the Mayor and commissioners of the city of Garnett, Kansas,

Section One :- that the sum of *Two Hundred and Fifty Eight and 24/100* Dollars be and the same is hereby appropriated out of the General Fund in the hands of the City Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 6th day of August 1917 a list of which may be found on page of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Eight Hundred and Sixty and 73/100* Dollars be and the same is hereby appropriate out of the Water Werks Fund in the hands of the city Treasurer to pay th bills allowed against said fund at a regular meeting of said Board held the 6th day of August 1917. a list of which may be found on page the Journal of the proceedings of the Board on said date.

Section Three :-that the sum of *Four Hundred and Eleven and 13/100* Dollars be and the same is hereby appropri out of the Street fund in the hands of the city Treasurer to pay the bill allowed against said fund at a regular meeting of said Board held on 6th day of August 1917. a list of which may be found ~~any~~ on page the journal of the proceedings of the Board on said date.

Section Four :- that the sum of *Three Hundred and Twenty Three and 92/100* Dollars be and the same is hereby appropri out of the Electric Light Fund in the hands of the city Treasurer to pay bills allowed against said fund at a regular meeting of said Board held on the 6 - day of August 1917. a list of which may be found on page the Journal of the proceedings of the Board on said date.

Section Five :- that the sum of *Three and 50/100* Dollars be and the same is hereby appropr: out of the Cemetery Fund in the hands of the city Treasurer to pay the bills allowed against said fund at a regular meeting of said Board held the 6- day of July 1917. a list of which may be found on page of t: Journal of the proceedings of the Board on said date.

Section Six : that the sum of *Four Hundred and 85/100* Dollars be and the same is hereby appropriat out of the Paving Tax Fund No, (4) in the hands of the city Treasurer pay the bills allowed against said fund at a regular meeting of said Bo held on the 6- day of August 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section Seven :- that the sum of *One Hundred and Thirty Three and no/100* Dollars be and the same is hereby appro out of the Paving Tax Fund No, (3) in hands of the city treasurer to pay the bills allowed against said fund at a regular meeting of said Board held on the 6- day of August 1917. a list of which may be found on page of the Journal of the proceedings of the Board on said date.

Section *Eight* :- that the sum of *Seventy Six and 50/100* Dollars be and the same is hereby appropriated out of the Fire Department Fund in the hands of the city Treasurer to pay the Bills allowed against said Fund at a regular meeting of said Board held on the 5th day of March 1917. a list of which may be found on Page of the Journal of the proceedings of the Board on said Date.

Section *Wice* :- that the ~~XXXXXXXX~~ Mayor and City clerk be and are hereby authorized and instructed to draw warrants on the city treasurer to pay the bills allowed in the foregoing sections of this ordinance.

Section *Five* :- that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
