ORDINANCE NO. 2009-2

AN ORDINANCE AMENDING ORDINANCE NO. 2006-4 ENTITLED "AN ORDINANCE ESTABLISHING A VOLUNTEER RESCUE SQUAD FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS"

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

Section 1: Ordinance No. 2006-4 entitled, *An Ordinance Establishing a Volunteer*Rescue Squad for the Village of Chapin, Morgan County, Illinois, is hereby amended by adding the following paragraphs i and j to Section 1:

- i. All newly appointed members of the rescue squad shall serve an initial one-year probationary period to be monitored by the Chief. Upon completion of the one-year probationary period, the Chief will evaluate the member's performance and shall advise the Village's Fire and Safety Committee of his/her recommendation as to whether the member should remain a member of the rescue squad. The Village's Fire and Safety Committee shall consider the matter and make a recommendation to the President and Board of Trustees as to whether the member should remain a member of the rescue squad.
- j. On an annual basis, the Chief shall prepare and submit to the Village's Fire and Safety Committee a written inventory identifying the rescue squad's vehicles, equipment, and supplies.

Section 2: This ordinance shall be in full force and effect upon its passage and approval.
