Review the enclosed Sales Agreement, complete, and fax, scan, or mail to our office. Or just call us at 860-384-3691. You can also submit your sales agreement electronically on our website. There's no wait to receive your brochures! You'll receive your brochures within 4-5 days. Brochures will be shipped FREE! We will create your organization's custom online store.

We can also customize a participant letter to include your goals, dates, payment options, a link to the online store, directions for your participants to register as a seller, and tips for increasing sales.

Distribute brochures and participant letters to your sellers. Collect orders and payments with your brochures, share your online store link with family and friends, and sell for 2-3 weeks. We encourage closing on a Monday rather than a Friday to allow your participants to sell over the weekend. Customer checks, if accepted, are made payable to your organization.

Collect all brochures and payments at the end of your selling period. The minimum order is 50 items.

We will email an invoice for the amount due, and you'll keep your profit upfront. If you have online sales, we will send you a report for your sales and a check for your profit after the conclusion of your sale.

Shipping is FREE with a qualified order of 100 items sold! Orders less than 100 items will add \$50 shipping.

Pay for your purchase. Payment by school/organization check, money order, cashier's, or certified check is required.

Purchase Orders and payment by credit cards are not accepted for Sweet Chaos orders. W-9s and vendor applications are provided as needed.

A confirmation will be emailed to you once we receive payment. Once payment has been received, your order will be submitted to our shipping department for processing. Products are delivered via FedEx or Common Carrier generally within 1 week.

Report any missing or broken items. Seldom are items missing or broken with our shipments. However, should any corrections be required, return the check-in form within 48 hours and we will process a new order for the replacements.
