Mr. Archer stated that the proposed ordinance was a citizen request for improved traffic control in the area. The Council questioned which intersections in the area already had stop signs and whether an additional stop intersection would be helpful. Chief Preston offered to study conditions in the area and bring back data if the Council wanted to table the item to a later date.

#### L. Consider and Discuss Westbound Water Rates.

Mr. Archer presented the Council with a chart outlining the rate increases to Westbound Water over the last 15 years. He requests a 5% increase in the rate this year, bringing the rate to \$4.62 per one thousand gallons up to 3.5 million gallons and \$5.54 per one thousand gallons over 3.5 million.
