The next PFOC general meeting is scheduled for May 18th at North Mountain Visitor Center, 12950 N. 7th Street. In addition to the meeting, which begins at 7:30 p.m., we will have a program presented by Cynthia Woods, a board member for Guide Dogs of the Desert.

Guide Dogs of the Desert matches 25-30 teams annually, including Cynthia Woods, a certified vision rehabilitation therapist at the Foundation for Blind Children. Cynthia works with adults who, in most cases, have recently lost all or part of their vision. She has non-classic Retinitis Pigmentosa, which has taken her central vision and most of her peripheral vision.

"Guide Dogs of the Desert gave me my life back," said Cynthia. "I had to learn how to use a white cane before receiving my first dog, and although it gave me more independence, I hated it. I could hear people talking about me in public, and I didn't want their pity. When I began to work with my first dog, that changed."

She's had three guide dogs, and she's grown very close with them all. She received Tyus, in 1999. He was a beautiful yellow Lab who was trained to fly with Cynthia and her husband in the back seat of their airplane – wearing a headset to protect his ears, of course. He slept through most of the flights, but always awakened to 'check' the instruments over her husband's shoulder!

Jasper the Wonder Dog, a big black Lab with a silly personality, followed Tyus. He was a drooler, so Cynthia would tie a bandana around his neck to keep him tidy. Every morning, he would sit by the dresser where the clean bandanas were stored, waiting for his wardrobe to be chosen. He also put his dirty 'shirt' in the laundry basket every evening before bed. Biscuit was his successor and her current guide. She's a yellow Lab who never quite grew into her skin. She's extremely laid back, and people say that she reminds them of a soft, huggable stuffed animal.

"The perfect person/dog match is crucial to the success of a guide dog team, and Biscuit is definitely the perfect dog for me," says Cynthia. "When I'm at work, she sleeps in my office, occasionally entertaining my clients with snores and noisy dreams. She guides me down the aisles of the grocery store, finding doors and elevators, and taking me through the airport when I travel. On the rare occasions when she doesn't accompany me, I feel like I've lost my vision all over again."

The opportunity to work with guide dogs changed Cynthia's life. Because of her transforming experience, she pledged to do everything she can to make this wonderful opportunity available to others.



### 2017-2018 Phoenix Field & Obedience Club Awards Application Form

The purpose of PFOC's annual awards is to honor members who, with their dogs, have won obedience and other dog-related titles. The following policy is reviewed at least every 3 years. It shall be effective as of January 1, 2018.

#### I. Qualifications for an award:

- A. The applicant must be a PFOC member in good standing.
- B. The applicant must be the owner of the dog or a member of the immediate family or household of the owner.
- C. The applicant must have trained and shown the dog in earning the title being applied for.
- D. An applicant must have earned an AKC Beginner Novice or more advanced obedience title or a Rally Novice title to receive the original plaque.

**II.** One free plaque will be awarded per dog. Plaques are wooden and display the PFOC logo. A metal plate engraved with the dog's registered name and breed will appear on the plaque.

**III.** After the applicant has qualified for the original plaque, in accordance with I-A through D above, the applicant may apply for engraved metal plates recognizing individual titles. These will include title name and date earned. All non-AKC awards will have the awarding organization's initials appear before the title (example: NADAC, USDAA, ASCA). Metal plates may be purchased at a cost of \$7 each.

**IV.** All applications for all title awards must be accompanied by a copy of the title-awarding organization's certificate or acknowledgement of the title. If you have not received the certificate yet, a list of the shows or tests in which the dog received credits for the title must be sent. If you are applying for awards for multiple dogs, please use one application per dog and include copies of all titles being applied for.
