

## Kelly's Kidz Scholarship

Kelly's Kidz is a not-for profit whose mission is to help physically impaired kids live the best life that they can. We are offering \$3,000 in scholarship monies for any student with a physical impairment who is attending any type of post-secondary education.

### Process and Deadline:

Please complete and submit one application packet. **Please include all of the required materials within your application packet and fill out ALL REQUIRED INFORMATION, as incomplete packets will not be reviewed.** The Kelly's Kidz Scholarship Board will evaluate applications mid-April. Each awarded applicant will be notified of the decision by phone during early May, followed by a confirmation letter. All other applicants will be notified by mail thereafter.

Kelly's Kidz must receive a complete application packet including all of the below materials in order no later than March 31, 2017 for review. Remember that it is your responsibility to see that all forms are submitted on time.

### Application Packet Checklist:

- Scholarship Application Cover page
  - Fully complete all fields on the application cover page.
- Student Statement/Essay
  - Prepare a one-page typed essay-format document addressing the points below:
    - Tell the scholarship committee about yourself.
    - What are your educational goals?
    - What are your career goals?
    - Indicate any community program(s) you are/were involved in as an organizer, participant or volunteer.
- Proof of enrollment
  - Submit proof of enrollment from a college, university, vocational or training program. An acceptance letter, transcript and/or online printouts are acceptable as proof of enrollment.
- Proof of physical impairment
  - Please provide a note from your physician who states that you have a physical impairment and are being treated by him/her.
