ORDINANCE NO 5 OF 2023

TITLE: AN ORDINANCE AMENDING ORDINANCE NO 18 OF 2022 THAT BEING AN ORDINANCE SETTING THE SCHEDULE FOR 2023 REGULAR MEETINGS OF THE BOARD OF ALDERMEN OF THE TOWN OF GREENWOOD

Public comments: Resident B. Driggers, in favor of work session.

ORDINANCE NO. 7 of 2023

TITLE: AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF GREENWOOD, PARISH OF CADDO, STATE OF LOUISIANA, FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024.

Public Comments: Resident P. Coleman in favor of adopting the ordinance with amendments for police department officers, equipment and training. Also stated that the \$250,000 additional cost for two officers could be paid from Capital Fund and not General Fund.

TITLE: AN ORDINANCE TO SET THE SALARY OF THE CHIEF OF POLICE OF THE TOWN OF GREENWOOD EFFECTIVE JULY 1, 2023.

Public Comments: Resident T. Evans suggested more than the proposed amount. P. Coleman, resident, in favor of the proposed amount.

ORDINANCE No. 9 of 2023

TITLE: AN ORDINANCE TO SET THE SALARY OF THE TOWN CLERK OF THE TOWN OF GREENWOOD EFFECTIVE JULY 1, 2023.

Public Comments: Resident T. Evans, against Ordinance No. 9; Resident, P. Coleman against Ordinance No. 9 and wanted the record to reflect that the Town Clerk and Chief of Police are both exempt employees. Alderman Davis explained Chief of Police and Town Clerk increases were \$1.50 and not on a percentage basis. Alderman Larsen suggested that the term "salary exempt" be included in Ordinance No. 9.

ORDINANCE No. 10 of 2023

TITLE: AN ORDINANCE TO ADOPT THE MILLAGE RATE FOR THE TAX YEAR 2023 FOR AD VALOREM TAX TO BE USED FOR GENERAL OPERATING PURPOSES.

Public Comments: Resident B. Driggers suggested to increase the millage rate to fund the Police Department.

Adjourn to Regular Session: A motion was made by Alderman Davis, seconded by Alderman Larsen to adjourn from the Public Hearing into the Regular Session Meeting, the motion was carried by unanimous voice vote.

Staff Reports: Police Chief Shayne Gibson 1) no use of force incidents in the month of May 2) One officer hurt and is off and recovering. 3) Greenwood Community Clean up had a good turn out.

Chase Gowan, Utilities Manager, advised the Board 1) 2 service leaks repaired 2) the water usage average has gone down to 600,000 gallons per day which is normal for the time of year. 3) Explained the NOV letter. 4) Water plant did well during the power outage, only sewer issues. WHEREAS, the Board of Aldermen of the Town of Greenwood, Parish of Caddo, State of Louisiana have reviewed the

2023-2024 Budget;

THEREFORE BE IT ORDAINED by the Board of Aldermen of the Town of Greenwood that the salary of the Chief of Police of the Town of Greenwood shall be \$68,452.80 per year (salary exempt) with all other benefits as afforded all employees of the Town of Greenwood by Ordinance No. 11 of 2004, amended by Ordinance No. 2 of 2005, effective July 1,2006 and amended by Ordinance No. 7 of 2017 and revised by Ordinance No 2 of 2018.

Furthermore, it is approved that the Chief of Police be allowed to participate in the Louisiana Highway Safety Commission Grant Program and the Town be reimbursed as such from the State of Louisiana.
