If application is accepted, the defendant will enter into an agreement for pretrial diversion. Prosecution of the charge(s) will be deferred for 6 months. As long as the defendant does not receive any traffic citations or commit any serious traffic offenses during the 6-month diversion period, the charge(s) as stated on the diversion agreement will be dismissed.

I hereby apply to participate in the Traffic Diversion Program, waive a speedy trial and ask for a continuance of trial for at least 6 months until completion of the diversion period. I agree that failure to respond to information sought or the giving of false information on this application are grounds to deny me diversion or to remove me from the program. I admit that I committed the offense(s) alleged in the Notice to Appear (citation).

I further agree that if any portion of this diversion application is found to be invalid by subsequent change of the existing laws, the remainder of the diversion agreement shall remain in full force and effect.

If you meet eligibility criteria and are approved:

1. You and the City Prosecutor will sign the agreement.
2. You will be required to pay the court costs, fines and a diversion fee of \$75.00 at that time.  
**The \$25 application fee is separate and will not be applied toward the \$75.00 Diversion Fee.**
3. You must keep the Court informed of any change of address.
4. Your driving record will be checked periodically.

THE FOLLOWING VIOLATIONS ARE NOT ELIGIBLE

- ⊗ DUI
- ⊗ Reckless Driving
- ⊗ Attempt to Elude
- ⊗ Construction or school zone violations
- ⊗ Cross walk violations
- ⊗ Child restraint or seat belt violations

ADDITIONALLY, YOU ARE NOT ELIGIBLE IF YOU:

- ⊗ Hold a commercial driver's license and use it in your employment. **(BY KANSAS STATE LAW)**
- ⊗ Caused or contributed to the cause of an injury accident.
- ⊗ Have more than two traffic violations in the past 2 years or more than three traffic violations in the past 3 years.
