### **IMPORTANT INFORMATION ABOUT OPTIONAL ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE**

The 2014 Handbook for optional A D & D Insurance is available on the Delta Extranet website. This Handbook details some additional coverage that became effective on January 1, 2014.

The additional coverage that should be of interest to our aging group of retired pilots includes the following:

- **Emergency Medical Benefit when traveling more than 100 miles from home or travel out of the country.**
- **Emergency Medical Evacuation Benefit**
- **Return of Remains Benefit**
- **Burial and Cremation Benefit**
- **Accidental Death Mortgage Payment Benefit**

It is important to note that for some of the above benefits, the insurer, American Insurance Company (ACE), must authorize all expenses in advance and all services must be rendered by the designated assistance provider. More information about the coverage and the Travel Assistance Program is detailed in a memorandum which will be posted on the DDPSA website in an accompanying News post—see the second News post dated April 25, 2014 entitled Travel Assistance Program under A D & D insurance.

Pilots were eligible to purchase the optional A D & D insurance upon retirement in the amount of 50% of the coverage that existed immediately prior to retirement. When the pilot reaches age 80, the coverage amount is reduced to 25% of the pre-retirement coverage. If a pilot fails to purchase at the time of retirement or if the pilot ceases to continue the coverage at any time after retiring, the coverage cannot be reinstated (unless the pilot is rehired by Delta).

In order to access the Handbook for optional A D & D Insurance on the DeltaNet website, proceed as follows:

1. Log on to the **Delta Extranet** website at [www.dlnet.delta.com](http://www.dlnet.delta.com) using your PPR number and password.
2. Mouse over **Employee Information** and scroll down to **Self Service**.

3. Mouse over **My Benefits and Life Events** and scroll down to either **Health and Insurance Policy Information** or **Resource Materials (2013 and prior years)**.
4. Click on **Documents and Forms** on the left side of the screen.
5. Select **2014 A D & D Insurance Benefits Handbook**.
