- Reference put forward by Kirklees and inform the steering group and Kirklees of the decision Cllr Tolson **Seconded Vote: All in favour**
- 2. To review the Mirfield Toilets survey and agree a course of action and implement feedback from the survey - Cllr Guy talks Cllrs through the responses of the survey. Cllr Lees-Hamilton reports that once the Lidl site is complete, they will have customer toilets and this would alleviate much of the problem. For events, MTC could consider hiring porta-loos. Cllr Pinder put forward several proposals to keep the toilets open for a temporary period or for events until the Lidl site is completed, but did not have a seconder for the proposals. Cllrs discussed the expense involved in turnstiles, tokens and other suggestions from the survey, but could not justify the expense of these. Cllr Burton states that residents have been managing without the public toilets whilst they have been closed and that it is extremely difficult with the level of misuse and vandalism to keep the toilets clean to a standard that is expected from the survey. The Clerk reminds Cllrs that the asset transfer of the toilets is still pending and would need addressing asap. Cllr Burton Proposed MTC closes the public toilets permanently, gives 1 months' notice to Clan Services and informs Kirklees that MTC no longer wish to pursue the asset transfer of the toilets Cllr Benson Seconded Vote: 6 in favour Cllr Pinder against Cllrs Lees-Hamilton & Hirst abstained It is noted that Cllrs have made the decision from the results of the public survey. Cllrs thank Cllr Pinder for all his hard work as head of the Toilets Working Party.

2017/91339 – Land opposite 14 Bracken Hill. Residents from Bracken Hill are in attendance and object to the retrospective planning application. Residents report that the current build is higher, with dormer/velux windows that were not on the original application in 2015. They also report that the build does not match the character of the surrounding properties. Cllr Pinder states he is fed up of builders applying for retrospective permission and chipping away at the original to get what they want from a build. Cllrs discuss at length with the residents. Cllr Benson **Proposed** MTC objects on the basis of detrimental to highway safety both access and egress, over intensification of site, overlooking neighbouring properties, loss of privacy due to height of build, in contravene of BE12 and refer to highway comments in original application 2015/91816 and state that the practice of deliberately changing plans & applying for retrospective permission is becoming common and a lack of contact from building regulations to local residents is unacceptable Cllr Nottingham **Seconded**
