Group Homes (Provide home for adults with developmental disabilities)

3, 16, 126 Homewood Rd

3 Homewood had a lot of concerns but the one individual has been removed as a result of collaboration of Councilman Cartier, NCCPD and Conexio Care Staff.

There are 1-3 individuals living in each residence.

Each individual that is living there might have multi support staff and that is why there are multiple cars. The homes are fully staffed 24 hours a day.

If police are called it's because they have done everything they can and our police are trained to help in these situations.

There is an open line of communication with the group homes and our community to both coexist.

Councilman Cartier wished us all a happy holiday and encouraged neighbors to attend the holiday open house at Rockwood Park on December 1 & 2 from 5-9 pm and the Claymont Christmas Parade on Saturday, December 1st from 10 am to noon. He gave out updated pamphlets on frequently used phone numbers. The main one he focused on is complaints that are non urgent such as a home not being taken care of 302-395-5555. (Code Enforcement Report Attached)

Master Corporal DeJesus went over our call log for police dispatch. The Police log showed 21 calls over a 6 month time span. Only 2 calls were for criminal mischief and disorderly conduct. All other calls were for group home and handled. Master Corporal DeJesus stated we are in a very safe neighborhood but to remain aware of surroundings and stay vigilant. He went over what is a emergency vs non emergency

If you see someone breaking into a home or looking through windows of a car to call an emergency as it's actively happening.

If you come out to see your car has been gone through and it's daylight the criminal is not in sight to call the non-emergency line.

Master Corporal De Jesus described how our NCCPD has a Behavioral Health Unit (BHU) that is assigned a trained clinician on all mental health calls (24/7). Officers also have Critical Intervention Training (CIT) that has offered much insight to de-escalating situations and further developing empathy for citizens undergoing mental health crises. NCC also has a Mental Health Court and Veterans Court that are used to direct individuals to appropriate services.

Master Corporal DeJesus also brought up Project Lights On that delivers lightbulbs that turn on at dusk and off at dawn. They are led and solar to keep the cost down for the homeowner.

Several neighbors voiced concern regarding the safety of a young child riding a motorized bike (possibly electric) through the neighborhood on sidewalks and in the street. Master Corporal DeJesus recommended reporting this when occurring to the NCCPD non-emergency number for the safety of the child and those in the neighborhood.

DELAWARE'S BICYCLE LAWS AND SAFETY TIPS

An informative guide for parents And children providing bicycle laws an tips for bicycle safety.



RELIGION RECORDED

As of April 1, 1996, Delaware law requires everyone under the age of 16 to wear a helmet while riding a bicycle.

This applies to anyone who may be a passenger on a bicycle as well.

It also includes those in a restraint seat or in a trailer towed by a bicycle.

The standard of a helmet must meet or exceed the American National Standards Institute or the Snell Memorial Foundations 1984 standard.

(ANSI Z90.4 bicycle helmet standard)

SAFETY TIPS

- Wear clothing that makes you more visible. Always wear bright colors when riding.
- Bicycles should be inspected and tuned at regular intervals by a trained professional.
- Ride with the flow of traffic. Motorists are better able to predict your actions.
- Young children (under the age of nine) are not able to adjust to dangerous traffic situations. Therefore, they should not be allowed to ride in the street unsupervised
- Learn the "Rules of the Road." Bicycles are considered vehicles and bicyclists must obey the same traffic laws as motorists.

Any guardian who fails to cause that guardian's child to wear a bicycle helmet shall be fined for the 1st offense \$25 and \$50 for each subsequent offense. DE: 21:4198L 2. Every person riding a bicycle or other human powered vehicle shall have all the rights and all of the duties applicable to the driver of any vehicle. DE 21:4193 No bicycle shall be used to carry more persons at one time than the number for which it is designed or equipped, except that an adult rider may carry a child securely attached to the person in a back pack or sling. DE 21:4194

Delaware Laws

- No person riding upon any bicycle, coaster, roller coaster, sled, or toy vehi cle shall attach the same or personally be attached to any vehicle upon a high way. DE21:4197
- 5. No person riding upon any bicycle shall carry any package bundle or article which prevents the use of both hands in the control and operation of the bicy cle. A person operating a bicycle shall keep at least one hand on the handle bars at all times. DE 21:4197
- Every bicycle when in use at night shall be equipped with a font white light visible from a distance of at least 500 feet and a rear red reflector visible from 600 feet. DE 21:4198F

KID'S RULES

I. Be aware of all strangers

Parent, teachers and even police officers can't tell the difference between good strangers and bad strangers.

A stranger is anyone you do not know regardless of what they look like.

2. Trust your feelings

If a situation feels strange, run away, scream, kick and tell an adult you can trust. It is o.k. to ignore a stranger's attempts to talk to you.

3. Never go anywhere without telling an adult

If your parents don't know where you are, they cannot protect you if something happens.

4. If anyone, a stranger or even someone you know touches you in a way that hurts or makes you feel uncomfortable; TELL someone!

Remember, you are the boss of your body! There are laws to protect children from being touched in places that are considered "private parts."

Remember the NO-GO-TELL system. You should: I)Say NO if someone tries to touch you or makes you feel scared or uncomfortaor makes you feel scared or uncomfortaon do guickly way from the situation, ble, 2) GO quickly way from the situation, and 3) TELL a trusted adult .

An adult does not need to ask a child for help.

"Let me just take a picture of you for my company's website." Yell "NO!" and run away.

 "Let me give you a ride home or to school so you don't get in trouble for missing the bus."
 Don't fall for it. You could be in more

trouble in a car with a stranger.

 "Want to try this new candy? It's better than anything you ever had."
 This is just to get you within arm's length so they can grab you.

 "Here is some money. Can you take this package to that person on the corner?"

No! Don't accept anything from a stranger or go meet a stranger.

Strangers may ask for directions or try to entice a you to get in their car using various schemes. To keep from being grabbed and placed in the car, you should always stay more than an arm's reach from a vehicle.

Never approach a stranger's car.

You answer the phone and someone starts to ask you, "What's your starts to ask you, "What's your name? Where's your mommy? How old are you? Don't answer! Just hang up. "Don't tell anyone about talking to

"Don't tell anyone", me; it's our secret." Never keep secrets from your Never keep secrets from your parents, teachers or police. We are parents, protecting you.

Never Talk To Strangers! Whenever possible, don't go alone. Play or ride bikes with a friend – it's not only safer, it's a whole lot more fun

Use the buddy system.

 If you are separated from your parent, caregiver, or teacher in a public place.
 Go to an employee or security guard and not leave the site..

Please remember that there are other safe places, such as: stores, libraries and churches.

On the way to and from school and places avoid deserted areas and parking lots.

If you're old enough to go out alone, please remember to tell your parent the three Ws: 1)who you're going with, 2)where you'll be, and 3) When you'll return home. Inform them anytime your plans change.
