2010 Irrigation project update Mark advised the board that the Beeman Well testing and cleaning is complete. The well consistently produced 1200 gpm and ran between 1400 and 1800 gpm during testing. The pump is in design phase. The well video log showed significant buildup on the casing and perforations. Zimmerman recommended an acid treatment for the well. This process was completed and the video taken again. The amount of the additional service will be presented as a change order to the project at the next meeting. The irrigation system was turned on April 5, 2010. Customer meters are still in the testing phase and one meter has not been chosen as the main replacement meter as of this date.
