- Kammel Coulee Hill and the Spillway
- Semke Road turnaround
- Stromstad Road turnaround
- Loader Bucket

The Cornell Road deed was recorded. And we will contact Doug Meyers on the cost of the legal fees. We received another check from FEMA for \$8,284.55 for debris removal.

A motion was made and seconded to support the variance request for Keith Boraas. The motion carried. We also discussed a variance request for Paul Schallar. A motion was made and seconded that the board is not opposed to the variance request. The motion carried.

- Loader Bucket. Reviewed worn joints on bucket and cutting edge. No action taken.
