

Thanks for your interest in our program!

The following list of forms will need to be completed:

1. Letter to Physician, just have whoever your child usually sees to fill this out.
2. Participant Information and Health History, this is for you to complete, it will give me a little more insight into what we need to do to help the participant and keep things safe and positive.
3. Emergency Medical Consent, just in case of an emergency. I also require that a parent or legal guardian stay on site during the session.
4. Release of Liability, the legal stuff.
5. Louisiana Equine Liability Law, nothing to fill out, I just like everyone to be informed of their rights and obligations.
6. Tuition Waiver, if you need help with your riding fees.

Get these forms together and contact me so I can be sure to keep your participant on the list for the upcoming session! I will need to get with you about scheduling. When I get all of the details worked out, I will contact you with the place and time.

Unless otherwise informed, the *therapeutic riding* session is 10 weeks long with each participant riding once per week. If HATS is forced to cancel due to the weather or instructor illness, the ride may be made up at the end of the 10 week session, but if the rider cancels, no makeup rides are guaranteed. Please contact me in advance if the participant will not be able to attend. We will not continue to hold a spot for any participant who cancels excessively or does not show up at the specified time. The cost is \$350.00. If you need to apply for a scholarship, please let me know.

Please remember that our program is housed on private property. **Visitors are by appointment only.** Also, **DRIVE SLOWLY** into the parking areas! Riders should **wear pants and shoes that will not fall off while riding!** You may need **sunscreen or mosquito repellent.** **No pets, please!**

Directions to the facility: The address is 679 Beulah Church Rd, Calhoun, LA.

From Ruston, take I-20 East and take the Choudrant exit. Go right to Hwy 80, then turn left (toward Calhoun). Stay on Hwy 80, go past a green sign that says "Korean War Veterans Memorial Hwy," then turn right onto Owens Rd. Go over the railroad tracks and around a sharp curve, then make a right onto the short road that connects Owens to Beulah Church Rd, or if you miss it, just make a hard right onto Beulah Church Rd. Follow Beulah Church Rd. through a series of curves, past Beulah Church, then the driveway will be on the left. I should have the HATS banner hanging on the fence by the driveway.

From West Monroe, take I-20 to the Calhoun 101 exit. Turn left(south) and go back over the interstate, then turn right onto Hwy 80 (west) toward Choudrant. Turn left onto Owens Rd. Go over the railroad tracks and around a sharp curve, then make a right onto the short road that connects Owens to Beulah Church Rd, or if you miss it, just make a hard right onto Beulah Church Rd. Follow Beulah Church Rd. through a series of curves, past Beulah Church, then the driveway will be on the left. I should have the HATS banner hanging on the fence by the driveway. Please note that you will pass Beulah Rd on your way to Owens, but keep going to Owens Rd to avoid the railroad crossing without the crossing signals.
