ANNUAL SCHOOL MEETING PREPARATIONS:


A budget was presented with all of the information provided to date. From revenue standpoint, this year we will not have an additional \$200,000 sale of the rec area lot, so revenues have decreased significantly. Tuition amounts were based on a 3% increase over the fiscal year 2019 tuition rates, as the actual figures weren't available when the budget was prepared. Based on a budget of 1,023,476.00, the town is looking at estimated education spending per equalized pupil of \$15,835.38. Based on these figures, the estimated Homestead Education tax rate will be \$1.56.

The Annual School District Meeting Warning for the March 5, 2019 was then approved and signed by all three board members.

OTHER BUSINESS:

Every school potentially affected by the policy change will be receiving a qualifying questionnaire. Every school can defend themselves. School choice is still in place.
