WHEREAS, SOUTHWYCK COMMUNITY ASSOCIATION, INC. (hereinafter referred to as the "ASSOCIATION"), a Texas non-profit corporation organized under the Texas Non-Profit Corporation Act, as presently constituted, do by this writing consent to the following actions and adopt the following resolution:

WHERAS, Article V, Section 1(e) of the declarations for the various Southwyck subdivisions provides that Southwyck Community Association (the "Master Association") has the right to establish reasonable rules and regulations governing the use and enjoyment of the General Common Area;

WHEREAS, the Board of Directors desires to enhance the safety and enjoyment of the Association's common area properties, and protect the Association from damages caused by the usage of the common areas (parks) by groups for events; and

WHEREAS, such rules are necessary to help maintain the peacefulness and attractiveness of the subdivision and thereby support property values of the subdivision.

NOW THEREFORE, BE IT RESOLVED THAT the following Resolution Adopting Rules for Park Reservation and Usage is applicable to common areas owned by SOUTHWYCK COMMUNITY ASSOCIATION, INC. is hereby adopted:

- 1. The Release Form for Facilities Use/Hold Harmless Agreement, attached hereto as Exhibit "A," and incorporated herein for all purposes, must be completed by any group or organization seeking to utilize the park or other common areas.
- 2. The Southwyck Lake Park Group Use Rules & Reminders, attached hereto as Exhibit "B," and incorporated herein for all purposes, are hereby adopted and shall be enforced for any and all groups or organizations using the park or other common areas.
- 3. Damage/Cleanup Deposit Required: Reservations for groups with 30-49 participants shall require a \$100.00 deposit for any damage or cleanup costs. Reservations for groups with 50-99 participants shall require a \$200.00 deposit for any damage or cleanup costs. Reservations for groups with 100 or more participants shall require a \$500.00 deposit for any damage or cleanup costs. Damages or cleanup costs which exceed the amount of the deposit shall be charged to the organization and/or the party that requested the reservation. The Board of Directors of the Association, in its sole discretion, shall determine whether such charges are applicable, and whether a deposit shall be retained or refunded.
