3. COMMENTS FROM CITIZENS (6 minutes each)

Diane Fischer, 12 Newton Street – Ms. Fischer stated that the water company did work on her street and the area is sinking. Mr. Evans stated that he will contact Wilkinsburg-Penn Joint Water Authority and make them aware of the situation.

Sandra Ellifritz, 2838 McKelvey Road - Ms. Ellifritz asked how she could find out about terms of elected officials. Mr. Ursiny responded that she could contact Allegheny County Board of Elections.

DeWitt Walton, Allegheny County Executive Council – Mr. Walton shared with council and residents the Allegheny County budget and millage increase and provided the reasons for their decision.

Bruce Lavrinc, 42 Jefferson Street – Mr. Lavrinc asked council to terminate the manager and that he would be willing to take her place. He provided reasons for his recommendation. Further discussions followed.

Greg Barry, 574 Lorraine Road – Mr. Barry stated that there is a paper alley that accesses Brinton Rear that needs paved.

Sandra Ellifritz, 2838 McKelvey Road – Ms. Ellifritz inquired about grants.

Anthony Buba, 68 Ridge Road – Mr. Buba explained that grants have requirements and some are difficult to obtain.

Derek Dauphin, Representative of Pittsburgh Regional Transit – Mr. Dauphin presented the bus line redesign and its affect on Braddock Hills Borough.

Michael Ursiny, 2754 Columbia Avenue – Mr. Ursiny stated that he is lifelong rider and concerned about the service cut. He asked them to understand the community and the effects of their decision.

Mr. Evans asked what criteria, besides money, was used to determine their decision. Mr. Dauphin replied that they analyze ridership, limited funds, demographic factors and who will be dependent on public transportation when deciding cuts.

Mr. Evans asked them to look into the older and low-income population in the Borough.

Mr. Walton expressed his concerns and discussed the studies. He stated that he wants Braddock Hills to have good bus service and hopes PRT takes into consideration everyone's arguments when redesigning the bus line.

Janice Buba, 68 Ridge Road – Ms. Buba explained the difficulty for residents to walk along Brinton Road if stops were redesigned.
