Rules Lawyer by Joe Rosenberg, Rules Interpreter

Some food for thought as we prepare for the upcoming season:

1. Know the rules of competition. We do several leagues and tournaments. Each may have their own take on the rules. The Assignor should have those and will disseminate them to you.
2. NFHS rules a more focused on safety and participation than pro rules. We must keep the student athlete in mind.
3. There are rules we do not like. That is no excuse for not enforcing them. There are rules as written, as interpreted and enforced, which may be subject to your judgement. Please understand this is a fine line.
4. When explaining things to players and coaches, use rulebook terminology.
5. The game is not about you as an umpire; it is about the players. You are there to make sure the game is played fairly. Be humble, professional, and respectful.
6. Help your assigners. If you work for more than one group, make sure your blocks are in place and your availability is up to date.
7. Pre and post-game with your partner. Understand what went well and what did not work so well. Self-evaluate if you can. If you don't understand something talk to a more experienced official; your mentors and crew chiefs are there to help you. Or bring it up for a discussion at a meeting.
8. Know the rule book. Know proper positioning (mechanics) to make the call. This will help you to

get the call right. We, as umpires, know that we will not get all of them correct, but proper positioning will give you the best shot. If you need help go to your partner. That said, know what calls you can go for help on. Coaches will ask you to go for help; they do not know that in some cases you can't go. So, in these cases, know your priorities.

9. Communicate with your partner prior to the game, during the game and after.

10. Have fun out there.

The Supervisor of Officials and I will be introducing rule quizzes this year. Suffice to say, we will have a weekly quiz containing say 5 questions or so. We want you to open the book and look. Rules will be based on the NFHS book. Introduction date is planned for February 1st. ⚾

Stay Sharp (answers to the last page)

Happy 2026 to all our members and cadets! Lots of change in the air this year. We have a large cadet class, a school leaving and a new one coming, a new SOO and Cadet instructor as well as a new Rules Interpreter. But, Baseball will always be baseball and you will be needed to arbitrate rules for each game. Stay sharp and be as available as possible!

Additionally, we are back to Arbiter for assignments as well as other important things.

For one—you will be registering with NJSIAA through Arbiter. To Register, log in to Arbiter (make sure you go to #114548 account—not

the old South Jersey one). Once in, locate the "ELIGIBILITY" header and click it. You will see a sub header for "Registration". Click on "NJSIAA 2025-26 Registration" and then "Baseball". This will take you down the path of registration.

Secondly, the concussion certificate course is also taken through Arbiter. Click the "ELIGIBILITY" header again and then the sub header "Eligibility". Under Current Eligibility, click "2025-2026 Baseball Active". A page will be presented that has all your current eligibility items. One of them will be "NJSIAA Concussion Protocol Training". There

is a blue link "Take Online Clinic". Once completed, that part of eligibility will eventually be updated in Arbiter. Make sure you keep a copy of your completion certificate for your own records in case the system does not update properly. There is no need to send me the certificate.

Finally, please take note of the important dates on the front page. All of the meeting dates are listed. Meetings will be held once again at the Westampton Rec Center (50 Springside Rd, Westampton Township) starting at 7:00pm. Hope to see everyone there. ⚾
