We will be transferring a portion of the Reserves into a 12 -24 month CDARS (Certificate of Deposit Account Registry Service) and other amounts based on upcoming projects into 6-9 month CDARS. We will review the Reserve Study dates to determine amounts and into what monthly durations we can invest. A CDARS is a Certificate of Deposit Account Registry Service which BB&T will place funds we identify into CDs issued by a network of banks in increments under the standard FDIC insurance maximums. Making both principal and interest eligible for FDIC coverage.

12. Architectural & Park Beautification Report – Bob Clausen

Bob reported that throughout the year, there were a standard amount of requests for painting, planting and other various improvements. As a park-wide beautification project, we promoted a 'Palm Tree Drive' to replant many of our trees that have been lost over the years. The trees were planted in January and a total of 66 trees were planted. The park budgeted funds to support this project; total project was \$6,930, residents paid \$4,275 for a net expense of \$2,655. The park planted 9 palms in common areas or easements. Palm trees chosen were a Fox Tail variety that self-prunes, therefore, money normally spent on future pruning will offset the difference in cost.

13. BWV Manager's Report – Stacy Brown

Stacy reported 2018 sales; 10 Shareholder homes, 14 Rental homes, 6 Park Owned homes for a total of 30 units sold. 2018 sales are lower than previous years and inventory remains low. L-3 is a park owned unit under renovation. We have a total of 9 park owned units. We have 26 empty lots including those that are slated to be demolished within a short period of time. Our eviction rate has reduced and we currently have 2 units that are behind. The office is working with them to catch up. Stacy read a letter from Crown Capital praising her Contractor Program and urging the park to move inventory as quickly as possible. The new unit has been actively listed since 12/28/18 and is getting interest. Stacy mentions 20 comparisons within a 3 mile radius priced at \$100k or above.

Actions taken by Manager: camera's located Amsterdam and Holland. New homes to allow wood or composite stairs, varied skirting and lawn seeding. According to attorney, Scott Gordon, the Board needs to recognize the change in standards, trends and codes. He suggests a committee be formed to update the park's Rules & Regulations. Bob Clausen acknowledges the need and will address in February Board Meeting with the Attorney present. N-1 is listed at \$116k without a share. Unit demolition; J-15, J-18, I-10 and C-3. Speaker & Alexa purchased from contingency funds.
