The Town Council met September 18, 2017 at 6:00 p.m. in the Thorsby Municipal Annex Building.

New Business

Mayor Hight stated the first New Business was the Budget.

Mayor Hight reported to the Council there was an error on the water rates on Ordinance 174-B. He explained that it should have been \$4.55 and \$5.55 and not \$7.00 and \$8.00.

Council Member Collins moved to amend Ordinance 174-B from \$7.00 to \$4.55 and \$8.00 to \$5.55. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Collins, Benson, Chapman and Crumpton.

Mayor Hight reported there is a tree on the Towns property by the Dollar General that need to be taken down. Terry Jackson got an estimate from Wes Blair for \$1500.00 and that's with town cleaning it up. The Council asked to get more prices. Mayor Hight stated he would get more prices and bring them back to the next Council Meeting.

Mayor Hight gave the Council a copy of Kyle Porter offer on property that joins the park.

Mayor Hight gave the Council a copy of the engagement letter from I.H. McNeill for the Towns audit, he explained the price remanded the same.
