- Collaborates with Upper Township, Cape May County
- Hub for community news, events, and advocacy

# Why We Did the Survey

- Understand evolving community needs
- Align programming with member priorities
- Shape advocacy efforts
- To inform needs to a newly elected Board

## Methodology

- Distributed via Survey Monkey
- Sent to all current SIA members
- Open for 10 days
- Multiple reminder emails
- - Respondents: 129
- Sent to mailing list: 493
- 26% response rate (average response rate: 10-30%)

## Who Responded

- 65% Seasonal Residents
- 77% Involved in Strathmere 10+ Years
- - 87% Homeowners
- - 42% Over Age 65
- - 100% Age 35 or Older

## Community Engagement

- <50% have attended past SIA events</li>
- -- 99% feel a strong sense of belonging
- Top requested activities:
- Family-friendly educational programs
- Community service projects
- Social gatherings

## Additional Insights

- Speed Limits: 61% favor current limits
- Jitney to Sea Isle City: Popular request
- Lighting & Environment: Interest in light pollution education
- Construction & Landscaping: Support for eco-friendly materials

- Better boat/jet ski regulation
- Protect small-town character
- Improve signage
- Productive, not complaint-driven meetings
- Maintain Upper Township ties
