



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.careplanusa.com and CarePlan USA and governs data collection and usage. Collection of your Personal Information

CarePlan USA may collect personally identifiable information, such as your name. CarePlan USA may also collect anonymous demographic information, which is not unique to you, such as your age and gender. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by CarePlan USA. This information can include: your IP address, browser type, domain names, access times and referring website addresses.
