ENTRIES: Please see the "General Regulations and Entry Specification Section" for additional policies that this show subscribes and follows. **Entries will be accepted on a first come basis, and processed in the order received. Entries must include all signatures, Coggins, Vaccines, USEF/Indiana Waiver all association numbers for owner/rider/trainer/horse, payment and all documentation must be legible. When the competition is filled, a waiting list will be established.** If entry is received without funds, It will NOT be processed until funds are received. CONFIRMATION/TIMES: Confirmation of entry will be e-mailed. All e-mail addresses must be clearly printed. Ride times and show updates will be posted at www.HarmonyInTheParkDressageShow.com and equestrian-hub.com. It is the responsibility of the rider to inform show management of any time conflicts as soon as possible after receiving ride times. Classes may not be run in the order listed below.

LATE ENTRIES: Entries postmarked after closing date, include \$20 late fee per show. Entry is considered late if incomplete after closing date.

COGGINS/VACCINATIONS/HEALTH CERTIFICATES: Include a current Coggins copy within 12 months of show date. All horses must have proof of Equine Influenza and Equine Herpes Vaccinations within 6 months of show date (GR844). Health certificate required for out of state horses. These documents must list the same horse name and description as is listed on the entry blank and on the USEF horse identification or recording documents (GR845)

ENTRY CHANGES: May be accepted if scheduling permits with a \$10 change fee plus regular class fee and must be made by Noon the day prior to start of the class. All "**NO SHOWS**" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

REFUNDS: Refunds minus the full office fee(s) on or before closing date with request in writing. **No refunds for any reason after the closing date. Exception: After closing date ½ stall fee and shavings fee will be refunded, if show secretary is contacted before the show. NO SHOWS will not be refunded.** All regional championship qualifying fees paid to show management must be submitted to USDF, including fees from riders that scratched, were eliminated, excused or did not show up for the class. Competition entry fees in the event of cancellation of classes due to severe weather or other emergencies WILL NOT be refunded. GR 901.1, GR832

ARENAS/FOOTING: Three 20m x 60m sand and fiber competition arenas. Large sand & fiber warm-up ring. Show may elect to run Introductory through Training 2 classes in 20m x 40m arena. Para Equestrian Grade I -III will be held in a 20m x 40m arena. Para Equestrian Grade IV & V will be held in a 20m x 60 m arena. Separate sand lunge area.

AWARDS: Divisions (Jr/YR, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open. Riders may enter only one division per class. 1st place award and ribbons to third place for each class. No ribbons for Qualifying classes. Championships and reserves awarded for the highest percentage at each USDF/USEF/FEI level in each division **for HARMONY I only**. Overall High Percentage for each division will be awarded Show I only. Highest Percentage of Weekend will be awarded on Sunday. **Awards will not be mailed....competitor must pick up before leaving the show.**

QUALIFYING CLASSES: Please indicate that the class is to count for qualifying by placing a **Q** after the class number. Qualifying will not require a separate ride. An exhibitor riding in the Open, Adult Amateur, or Junior/Young rider classes will pay an additional \$20 qualifying fee to have this score entered in the Great American/USDF qualifying class at that level.

STABLING: 10x10 permanent stalls with full doors. Special requests will be considered but not guaranteed. Bedding available on grounds and may be pre-purchased on entry form. Initial bedding not included. Stalls available Thursday 1pm through Sunday 7pm. Stabling assignments will be posted on www.HarmonyInTheParkDressageShow.com. **Smoking is not permitted in barn area**

DIRECTIONS: From Indianapolis, take I-65 south to exit 76B (US-31). Take US-31 north 3 miles to 800S, turn left (west) towards Camp Atterbury. 4 miles to Schoolhouse road. Turn right and go 1/2 mile to Hoosier Horse Park, 7105 S. Kerns St., Edinburgh, IN 46124

PARKING: Parking will be in designated areas only both for trailers and vehicles. Non compliant vehicles will be towed at owner's expense.

DOGS/Pets: Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card and may be subject to penalty under Chapter 7.

7 must be on a leash no longer than 6' and attached to a responsible person. A \$50 fine may be imposed if the rule is violated.

IMPORTANT

GROUND CLEAN-UP: Before departure, please clean up the area around your stalls. In other words, **PICK UP AFTER YOURSELVES!**

MOTORIZED VEHICLES: Four wheelers, three wheelers, mopeds, small motor bikes or other motorized vehicles **ARE NOT ALLOWED AT ANY TIME ON HOOSIER HORSE PARK GROUNDS.**

FOOD SERVICE: WILL BE AVAILABLE ON GROUNDS. Bottled water will be available at the awards desk.

SAFE SPORT REMINDER: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants **MUST** adhere to the U. S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies.

TIME SCHEDULE AND RIDE TIMES: **MUST** be posted by noon day before the competition either in electronic format and/or in an area where social distancing can be adhered to.

FREESTYLES AND MUSIC: Submit two copies of your music on CD and/or digital files (MP3 and/or WAV). It must be clearly labeled with entry name, number and music directions and delivered to the announcer at least 3 hours prior to the start of the class and picked up following the class. Unclaimed music will not be returned. Sound check will be Thursday Evening - also at the lunch break on Friday, May 15, 2026. DR129.6

EQUINE DRUGS AND MEDICATION REPORT FORMS: All USEF Medication Report Forms **MUST** be submitted electronically, unless online submission is absolutely impossible.

PONY MEASUREMENT: Only one handler is permitted to bring the horse or pony to the measurement area. If more than one person arrives with the horse or pony to be measured, the measuring official has the authority to ask the excess individuals to leave the measurement area. Handlers should stand on the off side of the horse or pony with as much distance between themselves and the withers as possible, while continuing to handle the horse or pony safely. Horse or pony in need of a USEF pony measurement card, an appointment **MUST** be made with the show secretary prior to the show and coordinated with the Vet on Call.

TACK INSPECTIONS: Visual tack inspections will be done for 1/3 of the horses in the class for level 1-3 competitions. The Technical Delegate may follow the competitor to a designated area if necessary. **Equipment check for 50% of competitors. Technical Delegate will be available throughout the competition or grounds or in barns to answer questions on equipment.**

ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (USDF and USEF) for horse, owner, rider, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.

General regulations, policies and entry specifications

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH

US EQUESTRIAN FEDERATION rules are in force from the moment show management allows access to the showgrounds. This includes conduct, correct saddlery and equipment, and attire.

Liability — Horses by their inherent nature present a risk. This show, the management, the USEF Licensee, and the facility will not be responsible for any loss or damage or injury to horses exhibited, or for any article of any kind or nature that may be lost or destroyed, or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor and shall indemnify the show, the management, the show committee and volunteers, the USEF Licensee, the USEF and USDF, or any member thereof, against all claims and demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of any such horse. All horses exhibited in this show participate entirely at the owner's risk. **Neither the Organizing Committee, show volunteers and staff, the facility or its owners, any host GMO, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes. (GR828.4)

Exhibitors should exercise extreme caution before medicating their horses and should be aware of the US EQUESTRIAN FEDERATION rules governing drugs and medications. Any questions about the use of certain medications and regarding Rule IV should be directed to the

Trainer: A trainer is defined as any adult who has responsibility for the horse on the competition grounds and must sign the entry form.

Hazardous Weather/Accident/Acts of God, and Emergency Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, accident, or emergency. Every effort will be made to reschedule with priority given to any Championship or qualifying classes being offered. **No refunds for cancellations due to hazardous weather, Acts of God, accidents, or emergencies.**

Bridle Numbers must be worn at all times when a horse is being exercised or ridden.

Safe Sport Statement: Reminder all USEF Life and Senior Active members as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport Training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at www.usef.org

Warning: Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities. Please be aware of the laws specific to the show location.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

Important notice to all affected parties: Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

Announcements: Class announcements and ride time announcements are a courtesy to the exhibitor and not all shows provide the capability of public address announcements. Exhibitors are responsible for presenting themselves to the ring at their designated time and accept the full responsibility for doing so. Competitions offering public announcements will make every effort to maintain a working PA system, but it is stressed that it is still the exhibitor's responsibility to be on time. No protest will be upheld, nor any ride time changed, on the basis of a PA breakdown or missed announcement. Ring stewards will also make every effort to keep people informed and entering the ring in a timely fashion. Exhibitors are responsible for knowing the correct show time and their scheduled performance time regardless of PA announcements or ring stewards. No protest will be upheld, nor ride time changed due to failure of the exhibitor to meeting their responsibilities.

Show Schedule and Ride Time Conflicts: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule. Official Ride

Times Schedule will be posted on the score board by noon the day before the competition.

Sharps Disposal: Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers are located at the end of each barn aisle in Barn L and Barn A

Protective Headgear: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. See USEF Rule DR121.1

Pony Measurement: Please contact the manager prior to the closing date to set an appointment for a measurement with the show veterinarian and technical delegate. A measurement fee of \$100 must be paid on entry. The measurement must take place prior to first pony test ride.

Adult Amateur Classes - Only active Federation members may obtain amateur status. Every person who has reached his/her 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur status issued by the Federation. Any person who has not reached his/her 18th birthday is an amateur and does not require amateur status.

JR/YR - Open to Juniors and Young Riders only; any rider is eligible until the end of the calendar year in which they reach the age of 21. Only riders ages 14-18 may ride FEI JR Tests. Only riders age 16-21 may ride FEI YR Tests. Only riders ages 12-16 may ride FEI Pony Tests. Must include birth date on entry form.

Non-U.S. Citizens and Foreign Competitors must provide proof, in English, of current membership in good standing in their respective National Federation, or hold current membership in good standing with the USEF.

No exhibitor may **withdraw horses** from a licensed show after it has commenced, or remove them from the show grounds without permission of the show secretary.

Health Papers: Riders should be aware that Interstate Health Papers are required to be in your vehicle when attending shows not within their home state. Some states also require health papers when transporting between facilities within the same state. Please contact your state veterinarian office for further information.

Sharps Disposal: Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers are located at the end of each barn aisle and within center aisles when center aisles are present within the barns.

- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

ATTENTION COMPETITORS—It is the responsibility of all riders to know the rules applying to showing in the Dressage Discipline. THE RULES MAY HAVE CHANGED FROM THE CURRENT RULE BOOK. IT IS THE COMPETITORS' RESPONSIBILITY TO CHECK THE CURRENT USEF RULE BOOK FOR ANY CHANGES. The listed rules are only general and are subject to change at the discretion of the Board of Directors of USEF. Current rules can be found on www.usef.org

All questions not covered in these rules and regulations shall be decided by the show management whose decision shall be final.

Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

Exhibitors are notified that any act of discourtesy or disobedience to the judges or officials, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee and other fees.

Show management reserves to itself the power to prohibit any person from attending or showing a horse in the ring and to remove any groom or horse from the show without being liable for compensation.

No person will be allowed in the show ring during the time of judging except the exhibitor and those having official or requested duties to perform.

It is the tradition of the show that riders be correctly attired for the class in question, that attendants be neatly dressed and the horses properly presented. Management may in its discretion bar any person from entering the ring if not suitably presented before an audience.

USDF Horse Welfare Statement

As those engaged in equestrian sport, we are committed to ensuring our horses receive the best possible care to the best of our ability. We acknowledge that we are the caretakers of our horses and as such we are committed to always, without exception, treating our horses with dignity, fairness, kindness, and understanding.

We realize that horses, whether in a herd or as an individual, will communicate contentment, fear, pain and confusion in the only way they can, which often takes the form of physical reactions that can be misinterpreted and misunderstood.

Horses with only an HID are not eligible. Owners must be current USDF Participating or Business members & USEF active members (Junior, Senior or Life) in good standing. Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan[®]/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan[®]/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan[®]/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

WARNING:

Under Indiana law, an equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.

I HAVE CAREFULLY READ THIS DOCUMENT IN ITS ENTIRETY, UNDERSTAND ALL OF ITS TERMS AND CONDITIONS, AND KNOW IT CONTAINS AN ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AS WELL AS A HOLD HARMLESS AND INDEMNIFICATION OBLIGATIONS.
