

MINUTES OF THE REGULAR  
WILSON PUBLIC LIBRARY BOARD MEETING  
Tuesday, November 12, 2025

The Library Board meeting was called to order at 12:00pm and the location of the Nebraska's Open Meetings Act was noted by President Patty Wolfe.
