Best to apply at a time when flow is at a minimum. Recharge as needed or after large flow with 8 ounces of product. To treat a sump, slowly pour in enough **SOYTRUS** to provide a one-inch layer.

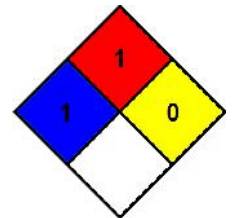
