

**RESOLUTION 2020-5  
ESTABLISHING UNIFORM EXPIRATION OF ADVISORY BOARD TERMS**

**A RESOLUTION ESTABLISHING A DECEMBER 31<sup>ST</sup> UNIFORM EXPIRATION OF THE TERMS OF APPOINTMENT OF MEMBERS OF THE PLANNING COMMISSION AND BOARD OF ZONING APPEALS; THE PARKS AND RECREATION ADVISORY BOARD; THE HOUSING AUTHORITY BOARD OF COMMISSIONERS; THE BOARD OF THE COMMUNITY FOUNDATION; THE TOURISM ADVISORY BOARD; AND, THE TERMS OF THE CITY APPOINTEES TO THE LIBRARY BOARD'S STANDING COMMITTEE FOR ARTWORK (COMMONLY REFERRED TO AS THE WALKER ART COMMITTEE).**

**WHEREAS,** the term of appointment of members of the Planning Commission/Board of Zoning Appeals; the Parks and Recreation Advisory Board; the Housing Authority Board of Commissioners; the Board of the Community Foundation; the Tourism Advisory Board; and the two members appointed by the City to the Library Board's Standing Committee for Artwork (commonly referred to as the Walker Art Committee) have rotating terms and each have various expiration dates for such terms; and,

**WHEREAS,** it is desirable to maintain the rotating term of members of each entity, in order that continuity may be preserved on each, but it would be more administratively efficient if each term on each board or entity had a common expiration date; and,

**WHEREAS,** December 31 of each year for such an expiration date would be the most convenient.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GARNETT, KANSAS, THAT:**

**SECTION 1:** The terms of the present appointees to the planning commission (and the Board of Zoning Appeals, which is staffed, ex officio, by members of the Planning Commission) shall be extended from April 1<sup>st</sup> to December 31<sup>st</sup> of the last

year of each member's present term. Thereafter, appointees replacing the present members shall hold office for a three year term, expiring on December 31<sup>st</sup>.

**SECTION 2:** The terms of the present appointees to the Parks and Recreation Advisory Board shall be extended from March 1<sup>st</sup> to December 31<sup>st</sup> of the last year of each member's present term. Thereafter, appointees replacing the present members shall hold office for a three year term, expiring on December 31<sup>st</sup>.

**SECTION 3:** The terms of the present appointees as Commissioners of the Garnett Housing Authority shall be extended from the various dates of inception to December 31<sup>st</sup> of the last year of each commissioner's present term. Thereafter, appointees replacing the present commissioners shall hold office for a three year term, expiring on December 31<sup>st</sup>.

**SECTION 4:** The terms of the present appointees to the Community Foundation Board shall be extended from March 1<sup>st</sup> to December 31<sup>st</sup> of the last year of each member's present term. Thereafter, appointees replacing the present members shall hold office for a three year term, expiring on December 31<sup>st</sup>.

**SECTION 5:** The terms of the present appointees to the Tourism Advisory Board shall be extended until December 31<sup>st</sup> following the expiration of the terms to which each is appointed. Thereafter, appointees replacing the present members shall hold office for a three year term, expiring on December 31<sup>st</sup>.

**SECTION 6:** The terms of the City's two present appointees to the Library Board's Standing Committee on Artwork (commonly referred to as the Walker Art Committee) shall be extended until December 31<sup>st</sup> following the expiration of the terms to which each of the two is appointed. Thereafter, the City appointees replacing the present members shall hold office for a three year term, expiring on December 31<sup>st</sup>.
