PARKING ON THE STREET IN OUR NEIGHBORHOOD

Southwyck has had a recent fire again, and it was noted by a neighbor that the fire trucks had great difficulty getting down the street with their truck. Perhaps a review of some specific Texas parking laws is in order. I'm sure you would have hated to have had your house on fire or even an ambulance needed, and they couldn't get down the street or to a fire hydrant because you, a family member, or neighbor park incorrectly on the street.

Section 545.302 provides precise Texas parking laws. Some of these laws are described below:

(a) An operator may not park a vehicle:

- on the roadway side of a vehicle stopped or parked at the edge or curb of a street
- on a sidewalk
- in an intersection
- on a crosswalk
- between a safety zone and the adjacent curb or within 30 feet on the curb opposite of the safety zone
- alongside or opposite a street excavation or if the parked vehicle would obstruct traffic
- on a bridge or in a tunnel
- on a railroad track
- where an official sign or other Texas parking law prohibits parking

(b) Under Texas parking laws, a person cannot temporarily park:

- in front of a public or private driveway
- within 15 feet of a fire hydrant
- within 20 feet of a crosswalk
- with 30 feet of a flashing signal
- within 20 feet of a driveway entrance
- with 50 feet of the nearest rail or railroad crossing
- where an official sign prohibits parking

Section 545.303 provides extremely specific Texas parking laws:

- a car must be parked parallel to a curb and be parked within 18 inches of the curb – THIS DOES NOT MEAN THE FRONT OR BACK OF THE VEHICLE AT THE CURB AND YOU ARE STICKING OUT INTO THE ROAD.
- a local authority by ordinance or Texas parking law may permit angle parking
- the Texas Department of Transportation may place signs anywhere they believe parking may obstruct parking

PARKING ON THE STREET IN OUR NEIGHBORHOOD—Continued

The Pearland Police department has a way for you to submit traffic complaints online. Again, this is within the City of Pearland and not the ETJ. Go to <https://www.pearlandtx.gov/departments/police/submit-traffic-complaints-online>. Here you will enter your contact information and a description of the violation, where the offense is taking place, and when the problem occurs so that a Pearland Police officer knows what they should be looking for, where they should be looking, and when the problem takes place. You can report the issue night or day. You may receive a call back if the officer needs more details, so you might want to take those calls from an unknown number for a time. If you wish to receive a copy of your submission, they have a place to reenter your email address.

YOUR CAR STICKERS MAY TELL MORE THAN YOU THINK

You may never have thought that the stickers you adhere to your car may be providing too much information. So, you have just slapped on the back of your minivan, the family stick figures. You have all 6 of your family represented on your back window. It is adorable! It is also dangerous. What a thief might see is you have your hands and mind busy with the four kids, and you can be easily distracted. Your car is parked at the daycare and you run in without a purse; the thief sees this as, 'she's got her hands full with the kids, I'll bet she left her purse in the car.' How about your NRA sticker proudly displayed? The would-be thief sees your advertising you most likely have a gun or two...maybe more in your possession and maybe even in the car or truck. While you may want to let everyone that sees your vehicle to know how proud you are of your choice of a presidential candidate, others may not like your choice and would vandalize your car because they do not like that individual.

You are allowed to put any sticker on your vehicle and express whatever you like. Just remember others might see your free expression as an opportunity. You watch what you post on social media, so watch what you post on your vehicle as well. A criminal mindset takes advantage of those that do not. Be mindful of what you are sharing about yourself and your family. You should take into account how this information could be used against you by someone with bad intentions. Don't become the victim, but be aware.

SCAM EMAILS

So I recently received an email informing me that my PayPal account had temporarily been restricted, and there was a button link to log into PayPal and confirm my identity. Perhaps you have received one of these emails. DO NOT CLICK ON THE BUTTON LINK. Take a look at the email address for the service@paypal.com that sent the email....does this look like an email address from a reputable company? Not at all.



Dear Customer,

Your PayPal account has been temporarily restricted.
We have found suspicious activity on credit cards linked to your PayPal account. You must confirm your identity to confirm that you own the credit card.


To maintain account security, please provide documents that confirm your identity.



After you complete the requested task, we will review the account and contact you about its status within 5 working days.

Thank you for your attention to this problem.

If you mouse over the friendly 'service@paypal.com' or click on Reply, you should be able to see the full email address of the sender. Most reputable companies have their domain name in the email address. They do not have a Hotmail, yahoo or Gmail account and certainly, a bunch of random-looking letters and numbers would not be a legitimate email address. So, before you click on any button or link in one of these emails, make sure you check the email address out. If it looks suspicious, it probably is. If you wanted to check your account on PayPal then enter the address yourself in the browser.

IT'S THAT TIME OF YEAR... VEHICLE BREAK-INS

It's car & truck break-in season. If you live near a major road, your chances of this happening are greater since the criminal wants to get out and away fast. If you see something that you suspect or is out of place please contact your local police. You can always call the non-emergency number for Pearland Police Department, 281-997-4100, or Brazoria County Sheriff's office, 281-756-2392. They get paid to investigate and show a presence, so never feel like you should not

call. Make sure you have both of these numbers in your cell phone. You never know when you might need them. If the issue is an emergency issue, call 9-1-1.

Use your porch lights. I look down my street in the evening and there are some very dark areas. Install motion sense lights or use LED which uses little electricity.

If you notice a street light out on your street or a street you walk on, use the Center Point streetlight outage website, https://www.centerpointenergy.com/en-us/residential/in-your-community/electric-outage-center/report-streetlight-outages?WT.ac=OC_Button&sa=ho. You will need the pole number. On our website, <http://SouthwyckTexas.com/local-resources.html>, you will find many of the common resources listed like Centerpoint

Do not make it easy for a thief. Lock your vehicles and do not leave valuables in your car. If you are not sure your car is locked, check. Having your car broken into is a huge hassle after it happens and it can be costly. Dealing with broken windows, stolen property, insurance claims and the uneasiness that a thief has gone through your belongs can be more of a problem than taking a moment to check to make sure your vehicles are locked and valuables removed. We do not want to attract thieves to our area because it is easy pickings.

ISSUE WITH SOUTHWYCK SECTION IV – UPDATE FROM OUR LEGAL COUNCIL

Dear Southwyck Homeowner:

Recently, the Board of Directors of the Southwyck Community Association, Inc. (the "Master Association") has learned that one or more members of the Board of Directors of Southwyck, Section IV Homeowners Association, Inc. (the "Village Association") has been providing false and inaccurate information to

the community about the relationship between the Master Association and the Section IV Village Association. We hope that this letter will clear up any confusion caused by this misinformation. Here are the facts:

Fact #1: The Declaration of Covenants, Conditions and Restrictions ("DCCRs"), which have applied to your property since Southwyck was developed, establish and create a two-tier governing system consisting of the Master Association and the Village Association. There are three Village associations in Southwyck: The Section I Village Association, the Section V Village Association and the Section IV Village Association.

Fact #2: The Master and Village associations are separate non-profit corporations which have separate functions as outlined in the DCCRs. The developer entity for Southwyck drafted the DCCRs, and any amendment of the DCCRs would require a majority vote of members of both the Master and Village associations, pursuant to an appellate court decision in 2017. That lawsuit was a result of the Section IV Village Association's Board of Directors attempt to amend the DCCRs without letting all members of the Master Association and Village Association vote on the issue.

Fact #3: The Fourteenth Court of Appeals has affirmed the Master Association's sole and exclusive right to collect maintenance assessments for both the Master and the Village (or "section") assessments as outlined in the Declaration. Any claim that the Master Association is not authorized to collect assessments on behalf of both the Master association and the Village Association is completely false. A copy of the court of appeals' opinion is available upon request. Once collected by the Master Association, the section assessments are then distributed by the Master Association to the appropriate Village association. This system has been in place since development. A Village Association does **not** have authority under the DCCRs to directly bill for or collect maintenance assessments independently of the Master Association. Accordingly, any billing or correspondence that you may receive from the Village Association attempting to collect maintenance assessments directly on its own behalf is unauthorized. Currently, the managing agent for the Master Association is Community Management Solutions, Inc. (CMSI). Authorized invoices for maintenance assessments will be sent by CMSI.

ISSUE WITH SOUTHWYCK SECTION IV – UPDATE FROM OUR LEGAL COUNCIL—continued

Fact #4: The Village Association is charged with deed restriction enforcement, and it is authorized to send bills for deed restriction violations. However, if at any time the Village Association fails to enforce deed restrictions, the Master Association also has the right to do so under the DCCRs.

There is another pending lawsuit filed by the Section IV Village Association against the Master Association, asserting various claims. Should you wish to obtain more information regarding the details and current status of the pending lawsuit, we strongly encourage you to attend the Board of Directors meeting of the Master Association, which is held on the first Thursday of each month. We value you as a member of the Master Association and Master Association Board of Directors wants to be as transparent as possible regarding recent events concerning the Section IV Village Association.
