BOROUGH OF BRADDOCK HILLS MINUTES REGULAR COUNCIL MEETING March 12, 2024

CALL TO ORDER

Thomas Evans President of Council, called to order the regularly scheduled council meeting at 7:01 p.m.

PLEDGE OF ALLEGIANCE

Mr. Ursiny led the Pledge of Allegiance.

3. COMMENTS FROM CITIZENS (6 minutes each)

Diane Bradford, 420 Jackston Street – Ms. Bradford requested that her son's name be included on the Memorial. Mr. Evans stated that they will include his name. Ms. Bradford stated that the trees on the vacant lot next to her house are a danger to her property. Mr. Evans responded that they will look into it. Ms. Bolton asked if we could look into all properties owned by Ms. Milko and take action.

Donald Tougher, 979 Illinois Avenue – Mr. Tougher stated that the intersection of Brinton Road and Columbia Avenue is dangerous due to speeding traffic and trees. He asked if the Borough could remove the trees.

Ms. Sorrentino stated that if the trees are on Borough property, the public works will work on trimming or removing as much as possible. However, they can only remove on the Right-of-Way if on private property. Mr. Barron added that Brinton Road is a State-owned road and they will be responsible for removing vegetation in the Right-of-Way.

Melody Farrin, 2826 McKelvey Road – Ms. Farrin asked that future events such as Community Yard Sale and Clean-up Day continue if there is rain in the forecast. She stated that events get canceled and never rescheduled and would like for it to be held unless the weather is extreme. Ms. Schaffer agreed and stated they would keep events scheduled rain or shine.
