New Member Liability Release

“General Release of Liability, Participant Agreement, and Acknowledgement of Risk for Any and All CVP Activities, CVP Events, CVP Meetings, or Any Type CVP Fund Raising Activity.”

1. *In consideration of being able to participate in any of the above activities, events, meetings, or fund raisers (collectively, the “Activities”), I do release, waive, and forever discharge the Central Valley Prospectors, AKA the Fresno (California) Chapter GPAA, and the officers, agents, as well as anyone acting on their behalf (collectively, the “Releasees”), from and against liability for any harm, injury, loss, damage, claim, demand, action, cause of action, cost, fee, and/or expense of any nature by me, regardless of cause, arising from or as a result of my participation the above reference Activities.*

2. *It is my express intent that this Release shall bind all members of my family and my personal representatives, estate, heirs, assigns, and successors in interest.*

3. *I have been advised and fully understand and accept my personal responsibility as a Participant in the above Activities to ensure that any guest I bring to attend any of the above Activities shall present a signed copy of this Release, prior to participation to any covered Activities, to the CVP officer or representative conducting the Activity. If such guest is under the age of 18, the Release must be signed and dated by a Parent or Legal Guardian.*

4. *I have signed this Release, as well as any Parent or Legal Guardian signing this Release, do so with express recognition and acknowledgement that the above Activities contain inherent dangers, hazards, and risks (collectively, the “Risks”) associated with the Activities in order to engage in prospecting, small mining, treasure hunting, and relic hunting, including the equipment used in performing these Activities.*

5. *I understand that Releasees may not have medical personnel available during the Activities neither have Releasees been trained to provide or conduct First Aid, and therefore, the above Risks are my own. I grant permission to Releasees to authorize emergency medical treatment, if necessary.*

6. *I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in any of the above Activities or else I agree to bear the costs of such injury or damage myself or to myself. I further certify that I have no medical or physical conditions which could interfere or jeopardize my health or safety while engaged in these Activities, or else I am willing to assume, and bear the cost of, all Risks that may be created, directly or indirectly, by any condition.*

7. *To repeat, along with the above, I hereby voluntarily Release, forever discharge, and agree to indemnify and hold harmless, the Releasees from any and all claims, demands, or cause of actions, which are in any way connected with my participation in the above Activities and associated Risks or my use of any related equipment or facilities, including any such claims which allege negligent actions of or by the Releasees.*

8. *Should the Releasees or anyone acting on their behalf be required to incur attorney fees and costs to enforce this Release, I agree to indemnify and hold harmless for all such fees and costs.*

9. *In signing this Release, I acknowledge and represent that I have fully informed myself of the content of the Release by reading it prior to signing it, that I understand what it means, and that I sign the Release of my own free will. I acknowledge that no representations, promises, statements, or inducements have been made to me that are not reflected in the terms of this Release. In giving consent, I agree to all the terms contained in the Release and agree to be fully bound by the terms thereof, in consideration for the inclusion to participate (including my family if applicable) in the above Activities.*

10. *I agree that this Release shall be construed in accordance with the laws of the State of California and that if any term or provision of this Release shall be deemed unenforceable or non-binding, the validity of the remaining provisions shall not be affected thereby.*
