1. Poles 12" butt (driven)
2. Stringers 3" x 8" x 12' drilled & bolted
3. Clamps 3" x 8" x 7' drilled & bolted
4. #1 Decking 2" x 8" x 6' router edges & secured w/20 penny nails
5. Any poles over 25' will be \$30.00 per foot per pole.
6. Any mooring poles / boatlift poles \$30.00 per foot per pole.
7. 3/4" bolts (galvanized)
8. 3/4" waterline & spigot included.
9. Removal & proper disposal of old pier.

ALL HARDWARE WILL BE HOT DIPPED GALVANIZED. ALL WORKMANSHIP & MATERIALS ARE GUARANTEED FOR 5 YEARS, WITH THE EXCEPTION OF DAMAGES CAUSED BY ANY ACT OF GOD.

All Material is guaranteed to be as specified, and the above work to be performed in accordance with the drawings and specifications as submitted for above Work and completed in a substantial workmanlike manner for the sum of Dollars **\$34,200.00** , with payments to be made as follows:

\$1,000.00 due at signing of contract.
\$11,000.00 due at starting of contract.
\$11,000.00 due mid-way through construction.
Remainder due upon completion and final inspection per AA County.
