Supervisor May called the board meeting to order at 7:00 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York.

Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting.

Public Comments:

Supervisor May requested a motion to approve the meeting minutes from May 12, 2022 with correction on page 6. On a motion from Mr. Herman, seconded by Mr. Ahl, to approve the minutes. Mary Kehl was introduced and welcomed by the Board. Ms. Kehl, explained that she is retiring from her position with Invenergy next week, Sean Perry will be attending our meetings going forward, he will be our point of contact. Ms.

Kehl also explained that Invenergy was given the Town, \$2,000 for Camp Wyomoco and \$5,000; \$2,500 for the Town Youth Programs and \$2,500 for the Seniors Group. GE and Chicago state that it will take over 180 days to repair the turbine on Glosser property. The Battery station should be up and running in a couple of weeks. Mrs. May thanked Mary for all of her work and communication with the Town during the entire process and instillation of the turbines.

Zoning Officer Report: Things are a bit slow this past month on permits. Mr. Suto stated that he has been contacted by a Solar Company, things would need to be approved by the state first.

Supervisor May introduced Ms. Justa Goodell, Animal Control Officer. Ms. Goodell, stated that our dog law is good, but we need to add information for if the dog leaves the residents property. She is working on a county wide enumeration, working with real property for names, address etc. She will keep us apprised on how the process is going.

<u>Highway Superintendent Report:</u> Mr. Roggow stated that they have been working on roads, ditching done on griffin road. Culvert on Dunham Road, and dirt roads are graded. We helped the county for the new fish trail on Krotz Road, and have been helping Perry pave. Went of Highway School, there was discussion about employees, retention and going green. DOT said that things will be changing, the state wants to regulate how much salt can be utilized on roadways. Trying to get salt usage down, they want town to use magnesium or a treated salt product. Fuels bids will do, for July or August. Mr. Roggow discussed that the new lawnmower will cost \$450.00. Informed that Mr. Tozier will be retiring September 1, 2022, we will have to advertise for a position. He has been with the Town of 35 years. We will try to get employee hired, in that training can be completed. We stated mowing roadsides, looking to call in some of our parttime employees. On a motion by Mr. Herman, seconded by Mr. Ahl to bring in part time employees and place ad for position opening. Supervisor May introduced Cindy Goral, she is the new director for the Tri-County Senior Group. Cindy will be attending our monthly meetings and make the Board aware of the group's activities. <u>Town Clerk Report:</u> Our Town website visits for May 2022 were 278, it appears that the site continues to vary how they monitor visits to our site. The Towns total revenue for the month of May was \$694.00, \$265.00 for Zoning, \$369.00 for dog licenses, \$50.00 for DEC and \$10.00 for other (late fees). We had 7 new licenses and 24 renewal licenses. To the general fund, \$389.76, Dogs were \$112.00, \$2.76 for DEC fees, \$10.00 for late fees, \$2.76 for DEC, \$265.00 for Zoning. We disbursed \$205.00 to Wyoming County, \$52.00 to Ag and Markets for dogs, and \$47.24 to DEC.

Supervisor May requested permission from the Board to sign the Intermunicipal Agreement with the Town of Bennington, for the mutual sharing plan, for the Assessment Review Board. On a motion by Mr. Flint, seconded by Mr. Boxler, to approve and sign the agreement. (There was a conflict of interest with the Assessment Review Board in the Town of Bennington, the Town of Orangeville's Assessment Review Board heard the review.)

Supervisor May requested a motion to approve the 2022 Highway Fund Bills: Abstract #6 Vouchers #94 through 106 totaling \$14,733.99. A motion was made by Mr. Herman, seconded by Mr. Flint to approve the payment of the Highway bills.
