

## MEMBERSHIP COMMITTEE REPORT

In April the membership committee completed a review of membership on record, compared to payments verified by the audit team. Here are the results:

**Total paid membership: 37,735**

**Total membership including pending payments: 40,004**

- 19 schools with 2269 members pending

**36 schools have not paid membership this year.** Cluster Coordinators and Area VPs have been notified to follow up. Some have paid MDPTA, but not MCCPTA. Some remain unaware that MCCPTA dues are separate from MDPTA and not invoiced. The "missing membership" from these schools totalled nearly 5,000 last year, which would bring us close to last year's membership.
