WHEREAS, the Corporate Authorities find that it is no longer necessary or useful to or for the best interests of the Village of Chapin, Illinois, to retain ownership of the personal property listed on Appendix A attached hereto; and

WHEREAS, the Corporate Authorities determine that it is in the best interests of the Village of Chapin to attempt to sell the personal property listed on Appendix A and to throw away and discard any items that are not sold.

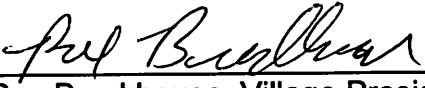
NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, as follows:

Section 1. Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the items of personal property listed on Appendix A, now owned by the Village of Chapin, are no longer necessary or useful to the Village and the best interests of the Village will be served by their sale and/or disposal.

Section 2. Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is hereby directed to take reasonable steps to attempt to sell the items listed on Appendix A but if unsuccessful or if it is unfeasible to sell the items to have them thrown away.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

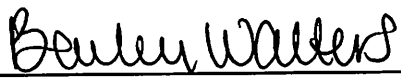
