AN ORDINANCE AUTHORIZING THE SALE OF REAL ESTATE
(517 CHAPIN STREET)

WHEREAS, in the opinion of the corporate authorities of the Village of Chapin, Illinois, it is no longer necessary or useful to or for the best interest of the Village of Chapin to retain ownership of the real estate commonly known as 517 Chapin Street, Chapin, Illinois;

WHEREAS, pursuant to the direction of the corporate authorities the Village Clerk published notice of the proposed sale and the Village's request for bids for 517 Chapin Street and that the bids would be opened at the regular meeting of the corporate authorities on June 12, 2019 at 7:00 p.m.; and

WHEREAS, Pamela Hopper submitted a bid of \$ 3,200.00 and the corporate authorities accepted said bid during its June 12, 2019 regular meeting.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, as follows:

Section 1. The foregoing recitals are incorporated herein by this reference as if they had been restated verbatim.

Section 2. The Village President and Village Clerk are hereby directed and authorized to take all necessary actions and to sign the attached *Contract for Sale of Real Estate* (Appendix A) and all other necessary documents to effectuate the sale of 517 Chapin Street to Pamela Hopper.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
