# Garnett, Kansas From The Commission...

With the beauty of a new season upon us, and the liberation that comes with warmer weather, I am all the more excited for the progress and opportunities our community continues to create. I am also thankful to have the privilege of serving as your mayor for this year. As I take on this role, it is my hope to bring positive contributions to our town.

Before I became a commissioner in 2018, the City of Garnett had been working to update its city code book, which contains all the ordinances, or laws, that are enforced by our town. The city hired CityCode Financial, LLC to assist in updating and reformatting our city code, which had not been extensively done since the publication of our 1961 code book. CityCode provided Garnett with a draft of the code in August of 2017. It then became the responsibility of the city to review, edit, and eventually adopt the new code.

As of today, we still have not finished this process. The commission has made progress in reviewing parts of the code over the past two years; however, this duty has often been relegated to the sidelines as other business comes up. It is my goal for this year to complete this process. Once we adopt the new layout and revisions in our code book, citizens will be able to access the updated codes online, in a very user-friendly format offered by CityCode. I believe it is essential that everyone living and/ or working in a municipality can

easily review the ordinances to which they are subject, and action needs to be taken to further this end.

Entering the spring season, as we have already started to see strong storm systems affect communities across the country, I wanted to inform everyone that the city is hopeful to have its new storm shelter installed before this storm season is over. The new public storm shelter is to be located west of the Train Depot and will always be open for use in inclement weather.

Finally, I hope this new season and the abundant opportunities for activity and involvement in our small community bring you and your family immense happiness. Recently, my boys and I have been studying the paintings of Jean Francois Millet (1814-1875). He was a realist painter who focused on depicting scenes of peasant farmers. One such painting, called The Winnower, shows a

man tossing grain up into the air from a basket, in order to separate the chaff from the grain.

The symbolism of separating the good from the bad, the useful from the useless, is striking, and particularly notable as we enter spring. As many of us begin to drive out the staleness that seems to inevitably settle into our houses during the colder months, and start opening our windows to the fresh air of a world brimming with life anew, I pray that everyone will be able to winnow out that which is bad, and actively seek that which is good. # From the City Manager...

At last, Spring is here! I'm excited for the next few months as we have a lot on our agenda. Unfortunately, we have had this COVID-19 virus grip our nation and disrupt the very fabric of our day-to-day lives. As we are under a statewide stay-at-home order and will continue to be for at least the next few weeks, please know that we at City Hall will continue to be here to answer your questions and provide all essential services. We still plan to move forward with various street projects over the



course of this spring and summer in addition to other projects.

You might have noticed several of our camping spots filled already this year. The Southern Star Pipeline project has filled some spots that normally sit empty until the middle of April. It is great to see residents and visitors utilizing the campgrounds! Just remember to stay safe and practice social distancing during this pandemic. We have unfortunately had to close off access to our playground equipment as the virus can last for a significant amount of time on hard surfaces.

The city-wide garage sales and city wide clean up week have unfortunately been postponed for the time being, but we hope to be able to hold them later this summer, or certainly this fall if nothing else.

As you begin mowing your yards this spring, please make sure to avoid blowing any debris (grass, leaves, etc.) into the roadway or alleys. This is not only against the law, it is also dangerous. It can clog our stormwater drainage system, which causing flooding and deterioration of our roadways. Additionally, with Spring comes the increased risk of violent storms. We ask that all residents prepare for the threat of severe weather by making plans for yourself and your family in the event of a severe weather threat. You may also attend the local storm spotter and preparedness trainings put on by the Anderson County Emergency Management team. As a reminder, in the event of an after-hours power outage, City Hall staff will not be in the office unless a long-term outage is expected. If your power has been off for longer than 30 minutes, please contact City Hall at 785-448-5496. If you are unable to reach City Hall staff, please contact Anderson County Communications at 785-448-6823.

**Did you know?** When I first came to Garnett, I was unaware of the many amenities that the City has to offer. I thought it would be nice to include some of those, and our newest amenities, in Town Talk for our new residents. While some of these amenities' use has been restricted due to the pandemic, please make sure to utilize them once this is all over!

• Town Hall Center – Anyone can rent Town Hall Center by the hour for events such as birthday parties, baby/wedding showers, game nights, cooking/sales parties, reunions, etc. This venue

can accommodate up to 49 people and is very inexpensive to rent.

- The Storywalk The Garnett Public Library has created the Storywalk on the Prairie Spirit Rail Trail between Park Road and 1st Avenue. The stories change throughout the year, usually every 6-8 weeks. This is a fun way to incorporate reading with exercising. Make sure you stop by the Library for a prize after you finish the Storywalk!
- The Walker Art Collection While you are at the library, make sure you take a stroll over to the west side. The Walker Art Gallery is an art collection that you do not want to miss! The displays change throughout the year and you can often find pieces from local artists.
- The Rec The Garnett Recreation Center is home to many workout classes! You can participate in everything from Spin and Yoga to a variety of new programs too. Memberships are available and The Rec is open 24-hours a day!
- **Trout Fishing** The South Lake is stocked with Rainbow Trout multiple times every year. This is a great benefit to the avid fisher in your life.
- **Season Passes** You can purchase season passes to the Garnett Municipal Swimming Pool. A perfect hot weather activity, the pool opens on Memorial Day Weekend! Water Aerobics is also available!

# From the City Clerk...

As you all know, the COVID-19 virus has taken the world by storm and created some unforeseen hardship on everyone. To help combat the situation, Governor Laura Kelly issued Executive Order 20-05 on March 17<sup>th</sup>, 2020 to mitigate the spread of the COVID-19 virus. The order reads as follows:



"NOW, THEREFORE, pursuant to the authority vested in me as Governor of the State of Kansas, including the authority granted me by ICS.A. 48-924 and K.S.A. 48-925, in order to mitigate the economic effects of the spread of COVID-19 I hereby direct and order that all Kansas utility providers not under the jurisdiction of the Kansas Corporation Commission temporarily suspend the practice of disconnecting service to Kansas citizens for non-payment. This directive covers all electrical, natural gas, water, and telecommunications utilities as well as internet service providers who provide services to Kansas citizens."

This Executive Order will remain in force until rescinded, until May 1, 2020, or until the statewide State of Disaster Emergency proclaimed on March 12, 2020 relating to COVID-19 expires, whichever is earlier. A full copy of the Executive Order can be found on the governor.kansas.gov website.

As always, you may contact Garnett City Hall at (785) 448-5496 as our staff are continuing their daily duties even though facilities are closed to the public at this time. Please be aware even though utilities are not being shut off, prompt payment is still highly recommended as the bills are still required to be paid in order to avoid accruing a large bill and subsequent disconnec-

Please be aware that our driveup window is staffed and payments can be taken there or dropped in our drop box, as well as front office staff can take payments over the phone. Midland GIS will be mapping waterlines throughout Garnett during the spring and summer months to create a new GIS (Geographic Information System) for the City. This may require Midland employees to access private property, similar to the duties of the City's meter reader.

Announcement from **Garnett Recreation**: Due to COVID-19, there are some changes on the City's baseball and softball programs. The registration period is being extended until May 3. Register now at www.garnettrec.com. Persons not signed up by May 3 will not be guaranteed a spot on a team. Practices will begin on May 18, subject to adjustment. Games will be played from June 15 to July 31 to help accommodate all the teams in the league and to ensure everyone gets plenty of game time. No one team will play more than 14 games this season. In the case of rain, there will be no makeup games due to the late start of the season. There will not be any year end tournaments. All of this is subject to change, depending on how the COVID-19 situation runs its course.

The *last chance* filing date for persons interested in running for Garnett City Commissioner is 12:00 p.m. noon on June 1, 2020 at the Anderson County Clerk's Office located inside the courthouse. To be able to file, you must be a resident of Garnett; must be a registered voter and pay a filing fee of \$20. Election day is Tuesday, November 3.



## COVID-19: What it means to Garnett

As of the printing of this issue of *Town Talk*, we can tout Anderson County (and Garnett) as not having a confirmed case of COVID-19. While we stand alone with adjacent Allen County as the only remaining counties in Eastern Kansas not having such a confirmation, we ask you to continue your diligence to be safe and practice CDC guidelines while adhering to Kansas Governor Laura Kelly's "Stay Home" Order.

What does this mean to Garnett citizens? We have a few simple tips:

- Keep in contact with family or friends but keep a safe distance from each other (approximately 6 feet). Wash your hands with soap and water-often. Call the doctor if you think you are sick. Practicing good, common sense and teaching children to do the same is what can keep all of us safe, now and in the future.
- Stay informed: If you have internet, please visit www.simplygar nett.com, specifically our "Coronavirus" webpage. There you will find frequently updated information and links to other valuable resources. Watch our social media (Facebook, Twitter) for daily posts, and look to local newspapers for information.

Sign Up for CodeRed: The CodeRed emergency notification system is typically used in the event of severe weather, such as a tornado warning. However, the system is also used as a messaging system at the discretion of Anderson County Emergency Management during times like these. We encourage all residents to sign up for CodeRed through our website or contact ACEM for more information, 785.448.6797.

# 2020 Guide to Garnett Outdoor Recreation





### Watersports

As a participant in the Kansas Department of Wildlife, Parks and Tourism Communities Fisheries Assistance Program, the City of Garnett does not require city boating and fishing permits. However, state boater's registration and state fishing licenses are required. All existing ordinances regulating city parks are in effect. Copies of city park regulations are available at Garnett City Hall, 131 West 5th Avenue.

### **Boating**

Valid Kansas boater's registration is required to boat on Garnett city lakes.

Lake Garnett (a/k/a North Lake Park), 700 N. Lake Road

Speed boating and water-skiing is permitted on Lake Garnett May 1 to November 15, on the following specified days: Wednesdays, Thursdays and Sundays, the first and third Saturdays of each month, Memorial Day, July 4 and Labor Day, from 8:30 a.m. to sunset.

Crystal Lake (a/k/a South Lake), Veterans Memorial Park,

424 W. Veteran's Circle Drive (on US 59)

Canoes and fishing boats with electric powered motors are allowed on Crystal Lake. However, gas powered motors are prohibited.

Cedar Valley Reservoir, 20499 NW 1500 Road (located approximately 7 miles west of Garnett at Kentucky and 1500 Road)

Boating can be enjoyed year round on Cedar Valley Reservoir, weather permitting. This lake has 3 boat ramps and 3 floating docks.

### **Fishing**

Game fish stocked in Garnett's fishing areas include Walleye, Wiper, Channel Catfish, Flathead Catfish, Bluegill, Bullhead, White Bass, Green Sunfish, White Crappie, Black Crappie, Black Buffalo, Red-ear Sunfish, Large Mouth Bass and Rainbow Trout. Kansas fishing permits required.

### **Rainbow Trout Season**

Rainbow Trout Season is held annually at Crystal Lake from approximately November 1 thru April 15. The Kansas Department of Wildlife, Parks and Tourism requires that Kansas anglers 16 through 74 years of age and non-Kansas residents 16 and older must possess a valid fishing license. All anglers over 16 must possess a state trout permit. Anglers 15 years and younger no longer must possess a trout permit to fish in designated trout waters.

However, there is a daily creel limit of two (2) trout unless they purchase a trout permit which allows a full daily trout creel limit. The daily creel limit is 5 trout.

### **Camping**

Camping facilities are available in designated areas at all three city owned lakes. Camping permits are required.

A camping unit can stay at a city park campsite for up to seven consecutive nights. Upon the eighth day, the camping unit must leave the park for at least five nights or relocate to a campsite located in another Garnett city park.

### **Lake Garnett**

Fourteen camping spots are located on the east side of Lake Garnett (Clubhouse Bend, adjacent golf course) with electric and water hookups. Twelve camping spots with electric only hookups are located on the north side of the lake (Red Jacket, near dam). A designated wilderness campsite (tent camping or no hookup) is also located within the north side camping area.

### **Crystal Lake**

Five camping spots with electric and water can be found on the south side of Crystal Lake. Wilderness camping is permitted in a designated area near Prairie Spirit Trail.

### **Cedar Valley Reservoir**

Wilderness camping is very popular at this scenic lake. There are 12 camping spots close to the park entrance providing electrical hookups for camping. Nearby restroom facilities are also available from April 3 to October 1.

### **Reservations and Fees:**

Campsites located at Lake Garnett and Crystal Lake may be reserved by contacting Garnett City Hall. Otherwise, camping spots are available on a first come, first serve basis. Remit payment by using the permit envelopes provided at the "Iron Maiden" at the campsite of your choice. Large camping groups are encouraged to make prior reservations with Garnett City Hall, 785.448.5496. During community events camping availability may be limited.

Check-out time is  $3:00\ p.m.$  on the day of departure.

### **ATV Regulations**

City permits are required for anyone operating a motorized, non-highway vehicle at Cedar Valley Reservoir. Anyone possessing an age restricted permit (under 16 years of age) can operate an ATV only when accompanied by an adult (18 years of age or older) who possesses a valid city ATV permit and who is riding in the general proximity of the age restricted permittee. ATV permits can be purchased at Garnett City Hall, 131 W. 5th Avenue.

**Quiet Time:** Please note that "quiet time" is to be observed within any city park, from 11 p.m. to 6 a.m. (CST).

ing Committee may also meet via Zoom when necessary. Zoom is a website (or app) to watch, listen and participate during the regularly scheduled meetings. To watch and/or participate in an upcoming commission meeting, simply sign-up to receive city commission agendas on our website and the link to these meetings, along with the current meeting agenda, will be emailed to you before each meeting. As you may already know, city and county buildings are closed to the public at this time.

• Don't miss out on having fun! While the "Stay Home" Order sounds rough, it isn't meant to be. You are free to engage in outdoor activity providing you maintain the social distancing recommendation of six feet from another person and avoid gathering in groups (currently no more than 10 people but this number could be reduced at any time). You can walk the trail, enjoy Garnett's more than 1,000 acres of parks, but please for you and your children's safety, avoid touching playground equipment.

What is the census? The census is a count of all persons living in the United States. It is conducted every 10 years by the federal government and is required by the U.S. Constitution.

It is used to determine the number of seats each state has in the House of Representatives, how federal and state legislative districts are redrawn, and the appropriation of federally funded programs.

Census Day is April 1, 2020. Data collection began in March and continues through August 2020.

Households should have received a postcard with instructions for completing the census beginning in March.

PLEASE NOTE: The Census will NOT call or email you. The Census Bureau will never share a respondent's personal information with other government agencies. Data are only released in summary tables. No individual records are released.

# An Important Message From the Gas Department...

### For safety's sake, read this!

Things you should know:

- How, when and where to report a possible gas leak, gas odor, or carbon monoxide problem;
- Call Kansas One Call before you dig;
- Carbon Monoxide (CO) is known as "The Silent Killer";
- · Gas appliance connectors;
- Be aware of bare steel gas service lines.

It is that time to inform our customers on the hazards of natural gas, and what precautions to take to keep us all safe. Natural gas is very flammable, potentially hazardous, and can be explosive under certain conditions. You can recognize a gas leak by using your senses. Seeing bubbles appear in a wet or flooded area, dead or discolored vegetation in an otherwise healthy environment, or a sometimes quiet to rather loud hissing sound can be signs of a gas leak. However, in most cases a leak can be recognized by a weak to strong smell of odorant. Our gas system is always odorized so that people can easily detect a leak by its smell.

### How to report a possible gas leak

If you smell gas inside or outside a home, business or other structure, please report it to the gas department by calling Garnett City Hall at 785.448.5496. Call the Law Enforcement Dispatch Center at 785.448.6823 after normal business hours. If you have a gas emergency and the odor of natural gas is very strong and seems to be everywhere, DO NOT operate any light switches or try to air out the building, or even use your phone. EXIT IMMEDIATELY to a safe area away from the potential gas leak, such as going to a neighbor's house, and then call 9-1-1. Wait at your safe place for emergency personnel to arrive.

Our natural gas system transports gas to businesses and homes within the City of Garnett. Overall, this system is very reliable and in good condition. We have procedures, such as gas leak surveys, to determine where problem areas may exist and adapt as necessary. Accidents on gas systems are extremely rare but they can occur.

The gas department regularly trains with local emergency personnel, including fire, police and dispatchers. When a gas leak or related incident is reported, the proper department can be dispatched to provide public safety assistance and to respond to the gas emergency.

### Dig Safe - Call BEFORE you dig!

Always call Kansas One Call before you dig to have utilities marked. Do this not only for your safety, but because it is the law. Kansas One Call will notify utility companies to mark the area with paint and flags, if their utilities exist. If there are no utilities in the project area usually "OK" is painted on the ground along with a flag, or the utility company will contact you by phone. Contact Kansas One Call by dialing 8-1-1 (not 9-1-1) or by calling 1-800-DIG-SAFE. If you see what appears to be unauthorized excavation or destructive activities around our gas system, please give us a call at city hall at 784.448.5496 so we can investigate.

### The Silent Killer!

Carbon monoxide (CO) is a very toxic and sometimes deadly gas that is colorless and odorless. This gas is a product of incomplete combustion. Whenever you use your furnace, wood stove, hot water tank, stove, automobile or even your charcoal grill, CO is the gas that is produced and vented out of your home through a chimney, flue or vent pipe. All gas burning equipment

needs to be inspected and maintained regularly to keep it in good running condition. Chimneys and vent pipes need to be vented and kept in good working order as well. Carbon monoxide poisoning gives you flu like symptoms. So if you are seemingly not feeling very well, especially when at home, it could be a carbon monoxide problem. Call us. We can help by checking if carbon monoxide is a problem in your gas burning appliances. Every home should have a carbon monoxide detector and a smoke detector to help ensure your safety.

Gas connectors are corrugated metal tubes used to connect gas appliances in your home to gas supply pipes. Some of these old brass colored connectors can have a flaw in how the tubing was made and over time can separate causing a potentially serious gas leak. These uncoated brass connectors have not been made for almost 30 years now, but many are still in use. Although not all brass connectors have a flaw, it is very difficult to tell which ones do. Therefore, any uncoated brass colored connector should be replaced with either a plastic coated brass or stainless steel connector. Connectors can wear out from too much moving and bending and should always be inspected closely whenever an appliance is replaced or moved from its location.

Any additional gas safety related information is always free and available at Garnett City Hall.

### Bare Steel Gas Lines

Do I need to have my bare steel gas line replaced?

The Answer: Yes.

All bare steel gas lines are slowly corroding and will eventually leak and have to be replaced. We don't know when these lines may begin to leak which is why they need to be replaced before any leakage occurs. The Garnett Gas Department already has an ongoing program to replace all of the city's bare steel mains and service lines.

Back on August 28, 2007, the city commission passed an ordinance requiring the replacement of any existing customer owned gas service line at the time of the sale of the property or when any change in ownership occurs. It usually takes less than a day for one of our local, qualified plumbers to replace most bare steel service lines. Most of these plumbers will give you an estimate of how much it will cost.

### Excess Flow Valve (EFV)

Beginning in April of 2017, new federal regulations require every natural gas utility, including the City of Garnett, to notify customers about the potential benefits of an Excess Flow Valve (EFV), who is responsible for the initial installation costs and who is responsible for replacement and maintenance with an EFV. EFVs are mechanical shut-off devices that can be installed on the gas service line and is designed to shut off the flow of natural gas automatically if the service line breaks, say for instance, if a vehicle hits a meter or an excavation accident. We have detailed information online at www.simplygarnett.com/efv.html. I will include an article about this in the next newsletter. Watch for it.
